Resolve customer service problems



Overview

This unit is all about what to do when it is difficult to meet customer expectations. Even if the service you give is excellent, some customers will experience problems. Part of your job is to help to resolve those problems. A problem is anything that means customer expectations are not being met. This may be because your customer's expectations involve more than you can offer or because your service procedures have not been followed.

Some problems are reported by customers and sometimes you spot the problem first and resolve it before your customer has even noticed. As soon as you are aware of a problem, you need to consider the options and then choose a way to put it right. This unit is particularly important in customer service because many customers judge how good the customer service of your organisation is by the way problems are handled.

 - P6 work with others to identify and confirm the options to resolve a customer service problem
 - P7 work out the advantages and disadvantages of each option for your customer and your organisation
 - P8 pick the best option for your customer and your organisation
 - P9 identify for your customer other ways that problems may be resolved if you are unable to help
 - P10 discuss and agree the options for solving the problem with your customer
 - P11 take action to implement the option agreed with your customer
 - P12 work with others and your customer to make sure that any promises related to solving the problem are kept
 - P13 keep your customer fully informed about what is happening to resolve the problem
 - P14 check with your customer to make sure the problem has been resolved to their satisfaction
 - P15 give clear reasons to your customer when the problem has not been resolved to their satisfaction
 - P16 listen carefully to your customers about problems they have raised
