H5ST 04 (SCDHSC0370) — Support the Use of Technological Aids to Promote Independence

Overview

This standard identifies the requirements when you support individuals to use technological aids to promote their own independence. This includes working with individuals to identify appropriate technological aids, supporting them to use specific aids and contributing to the evaluation and review of their effectiveness.

Additional Information

Scope/range related to Performance Criteria

NOTE: Where an individual finds it difficult or impossible to express their own preferences and make decisions about their life, achievement of this standard may require the involvement of advocates or others who are able to represent the views and best interests of the individual.

Where there are language differences within the work setting, achievement of this standard may require the involvement of interpreters or translation services.

To **communicate** may include using the individual's preferred spoken language, the use of signs, the use of symbols or pictures, writing, objects of reference, communication passports, other non-verbal forms of communication, human and technological aids to communication.

The **individual** is the adult, child or young person you support or care for in your work.

Key people are those who are important to an individual and who can make a difference to his or her wellbeing. Key people may include family, friends, carers and others with whom the individual has a supportive relationship.

Others are your colleagues and other professionals whose work contributes to the individual's wellbeing and who enable you to carry out your role.

Scope/range related to Knowledge and Understanding

All knowledge statements must be applied in the context of this standard.

Factors that may affect the health, wellbeing and development of individuals may include: adverse circumstances or trauma before or during birth; autistic spectrum conditions; dementia; family circumstances; frailty; harm or abuse; injury; learning disability; medical conditions (chronic or acute); mental health; physical disability; physical ill health; poverty; profound or complex needs; sensory needs; social deprivation; substance misuse.

Values

Adherence to codes of practice or conduct where applicable to your role and the principles and values that underpin your work setting, including the rights of children, young people and adults. These include the rights:

- to be treated as an individual
- to be treated equally and not be discriminated against
- to be respected
- to have privacy
- to be treated in a dignified way
- to be protected from danger and harm
- to be supported and cared for in a way that meets their needs, takes account of their choices and also protects them
- to communicate using their preferred methods of communication and language
- to access information about themselves

Support the use of technological aids

8	Work with the individual at a pace that best suits their preferences and needs and in ways that promote active participation .	
9	Ensure that the selected technology is correctly installed and complies with health and safety requirements.	
10	Ensure that technological aids are used in ways and in places that maintain the individual's privacy and dignity.	
11	Support the individual to understand the technology and how it works.	
12	Check that the individual understands how the technology should be used and can put this into practice.	
13	Support the individual to communicate any issues, queries or concerns they have about using the technology.	
14	Clarify any misunderstandings about the purpose and use of the technology, seeking additional help where necessary.	
15	Give encouragement and constructive feedback to motivate the individual to use the technology and continue to do so over time.	
16	Work with the individual to identify any aspects of the technology that key people and others need to understand and/or use.	
17	Support key people and others to understand the nature and purpose of the technology and how to use it in ways that help promote the individual's independence.	

Support the use of technological aids (cont)

18	Support the individual, key people and others to address any difficulties encountered, seeking specialist support and advice where necessary.	
19	Support the individual to take appropriate and immediate action to deal with faulty equipment, in accordance with work setting requirements and any manufacturer's instructions and guidance.	

Contribute to evaluating the use of technological aids

20	Observe the effectiveness of technological aids in helping to promote the individual's independence over time.	
21	Agree with the individual, key people and others how the use of technology will be evaluated.	
22	Seek feedback from the individual, key people and others on the use and effectiveness of the technology.	
23	Work with the individual, key people and others to evaluate the technology, its use and the support provided.	
24	Agree any changes needed to improve the use and operation of the technology, including changing the technology where necessary.	
25	Ensure that you, key people and others carry out your agreed roles in making changes.	
26	Access specialist support where the scope of the technology or any difficulties encountered are outside your competence to deal with.	
27	Complete records and reports on actions, processes and outcomes according to legal and work setting requirements.
