It requires that the work is completed in accordance with site standard operating procedures.

Performance criteria

You must be able to:

- P1 ensure all work is carried out safely in accordance with relevant legal requirements and site procedures
- P2 organise the **resources** required to achieve planned production of farmed fish/shellfish for sale or transfer
- P3 control **production activities** to meet **customer** and quality requirements
- P4 monitor actual fish/shellfish production against planned production to highlight the need for modification to production activities
- P5 implement procedures to monitor and maintain fish/shellfish health and welfare
- P6 implement procedures to deal with problems that impact on planned production (such as variations in environmental conditions, malfunction of equipment, shortages of suitable stock and the poor health of fish)
- P7 maintain effective communication with customers and others involved in the production process
- P8 maintain records of fish/shellfish production to meet legal and quality audit requirements in accordance with site procedures

- K10 how to assess and maintain product quality and how fish and flesh quality is assessed and scored
- K11 relevant codes of practice, and their application in the control of farmed fish/shellfish production
- K12 factors that can disrupt production and the actions that can taken to minimise their impact
- K13 the value of effective communication with customers
- K14 the legal and quality requirements, and site procedures for maintaining records of fish/shellfish production
