*\*SCQF credit points are used to allocate credit to qualifications in the Scottish Credit and Qualifications Framework (SCQF). Each qualification in the Framework is allocated a number of SCQF credit points at an SCQF level. There are 12 SCQF levels, ranging from National 1 to Doctorates.*

**Purpose:** This Graded Unit is designed to provide evidence that the candidate has achieved the following principal aims of the HNC in Police Studies:

- ◆ to equip individuals with the knowledge and skills required to enter into a career as a Police Officer
- ◆ to develop individuals with the skills to enter into a wide variety of service related industries
- ◆ to prepare individuals for taking standard entrance tests for entry into Scottish Police Forces

**Recommended prior knowledge and skills:** It is recommended that the candidate should have completed or be in the process of completing the following Units relating to these specific aims prior to undertaking this Graded Unit:

**Core Skills:** There are no Core Skills embedded in this Graded Unit specification.

## General information for centres (cont)

**Assessment:** This examination-based Graded Unit is in two parts, the first part being closed-book and the second part being open-book. It will consist of an examination of three hours.

Paper 1 will assess Numeracy, Information Handling and Communication. The assessment will comprise restricted response questions lasting 1 hour, worth 30% of the total marks available. The questions in Part 1 will be in three sections and this part of the examination is closed-book.

The skills required for Paper 1 of the examination will be developed in the following Units:

Part 2 will be based on a case study. The case study will be made available to candidates two weeks prior to the examination. The questions will be unseen until the time of the examination. There will be at least three questions which should be answered in the form of a formal report.

# Higher National Graded Unit specification: instructions for designing the assessment task and assessing candidates

## Graded Unit title: Police Studies Graded Unit 1

### Conditions of assessment

This examination-based Group Award Graded Unit has two parts. The first part is a closed-book assessment and the second part is an open-book assessment. Together, both parts will form an examination of three hours duration.

Part 1 will assess Numeracy, Information Handling and Communication. The assessment will be restricted response questions lasting one hour. Each section of part 1 (Numeracy, Information Handling and Communication) should be designed to take 20 minutes to complete but candidates are free to use the one hour as they see fit. Part 1 is worth 30% of the total marks. Candidates will **not** be allowed access to a calculator for calculations in Paper 1. Questions in Part 1 should reflect a range of skills and topics related to:

**Communication** Questions should range from simple word choice, testing understanding of grammar, spelling or meaning of a word or phrase to questions related to interpretation of written passages.

**Numeracy** Between 10 and 15 questions should be set which cover a range from traditional numerical calculations to more complex financial and statistical calculations.

**Information Handling** Using graphs, charts, and tables of information, questions will require the candidate to present information and interpret and extract information.

The question topics in paper 1 should reflect the full range of the mandatory Units of the HNC in Police Studies.

Part 2 will be based on a case study. The case study will be a narrative of approximately two to three pages in length. It will be based on a scenario that reflects the type of issues that a Police Officer may come across in the execution of their duties. This scenario could be, for example, a description of a young offender and their family, together with the issues which they have been involved in; a description of a family who have been impacted by crime or another relevant scenario and related issues. The scenario will need to give ample detail of the situation and background, sufficient to allow candidates to answer questions which integrate the required skills and knowledge detailed above. The scenario should therefore provide detail to allow the candidates to identify, explain and discuss as appropriate issues relating to the three key question areas identified below.

The case study will be made available to candidates two weeks prior to the examination. The questions will be unseen until the time of the examination. Part 2 will last two hours and is worth 70% of the total mark. For Part 2 Candidates will be allowed access to three sides of A4 notes which must be submitted along with the completed Part 2 assessment. These notes should be typed in size 12 font (no smaller font will be accepted) and it is recommended that each side of A4 relates to one of the following three units:

- ◆ F1A7 34 *Scottish Legal System*
- ◆ DH3N 34 *Sociology for Social Care Practice*
- ◆ DE3R 34 *Personal Development Planning*

## Higher National Graded Unit specification: instructions for designing the assessment task and assessing candidates (cont)

The three questions set for the examination should cover issues related to:

- ◆ the sources of Scots Law and/or the roles of legal practitioners in Scotland and/or the system of public prosecution in Scotland and/or the powers of the civil and criminal courts in Scotland
- ◆ influence of the family on behaviour, experience and life chances and/or causes and impact of discrimination on behaviour, experiences and life chances and/or causes and impact of poverty and inequality on behaviour, experiences and life chances
- ◆ how the individual candidate could develop their skills and capabilities to deal with the issues presented in the case study in a more effective and efficient manner. This could relate to how they would plan their development, how they would implement it and/or how they would monitor and evaluate the plan in light of the circumstances

The examination questions should be unseen and the assessment should be conducted in controlled and invigilated conditions.

Reasonable assistance is the term used by SQA to describe the difference between providing candidates with some direction to generate the required evidence for assessment and providing too much support which would compromise the integrity of the assessment. Reasonable assistance is part of all learning and teaching processes.

In relation to the assessment of Higher National Examination-based Graded Units, assessors may provide advice and guidance on examination technique and clarification on the meaning of command words which may appear within an examination paper, prior to the formal examination.

Remediation is not allowed in Examination-based Graded Unit assessments.

Any candidate who has failed their Higher National Examination-based Graded Unit or wishes to upgrade their award must be given a re-assessment opportunity, or in exceptional circumstances, two re-assessment opportunities. This must be done by using a substantially different examination.

The final grading given must reflect the quality of the candidate's evidence at the time of the completion of the graded unit. Candidates must be awarded the highest grade achieved, whether through first sitting or through any re-assessment.

At all times, the security, integrity and confidentiality of examinations must be ensured.

### Instructions for designing the assessment task

The examination should be designed to assess the candidate's critical knowledge and understanding of the topics relating to the specific aims which this Graded Unit is designed to cover. The questions and corresponding marks should be designed in accordance with the ranges indicated in the table that follows. However, the overall total mark for the examination is 100.

The examination will be marked out of 100.

Assessors will aggregate the marks achieved by the candidate to arrive at an overall mark for the examination.

Assessors will then assign a grade to the candidate for this Graded Unit based on the following grade boundaries:

- ◆ A = 70% — 100%
- ◆ B = 60% — 69%
- ◆ C = 50% — 59%

### Guidance on grading candidates

The purpose of this Graded Unit is to integrate and apply the Knowledge and/or Skills gained by candidates in individual Units. By supporting its principal aims and affording opportunities to integrate learned knowledge and skills the Graded Unit will ensure candidates achieve the Group Award.

The Graded Unit should not, however, merely replicate assessment of any of the topics which have been previously assessed.

In addition to the above, this particular Graded Unit is designed to complement and help prepare candidates for the Scottish Police Standard Entrance Test.

The Graded Unit examination will take place towards the end of your HNC studies. The examination will consist of two parts, Part 1 will relate to the third principal aim of the award and Part 2 of the examination will relate to the first two principal aims of the award. The first part is a closed-book examination worth 30% of the overall mark. The second part is an open-book examination worth 70% of the marks.

The Graded Unit is a mandatory element of the HNC in Police Studies and will be awarded at the following grades:

- ◆ A = 70% — 100%
- ◆ B = 60% — 69%
- ◆ C = 50% — 59%
