## Gaelic (Learners): Using Language (Higher) Unit

**SCQF:** level 6 (9 SCQF credit points)

### Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop talking and writing skills in Gaelic, and to develop their knowledge and understanding of detailed and complex language in the contexts of society, learning, employability, and culture.

Learners who complete this Unit will be able to:

- 1 Use detailed and complex spoken language in conversations
- 2 Use detailed and complex written language

This Unit is a mandatory Unit of the Higher Gaelic (Learners) Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

The *Course Assessment Specification* for the Higher Gaelic (Learners) Course gives further mandatory information on Course coverage for learners taking this Unit as part of the Higher Gaelic (Learners) Course.

## Evidence Requirements for the Unit

For this Unit, learners will be required to provide evidence of their talking and writing skills by:

- ◆ using detailed and complex spoken language in at least one conversation
- ◆ using detailed and complex written language in at least one activity

Assessment generated for this Unit must come from one of the following contexts: society, learning, employability, or culture.

Evidence should be gathered in combination with other Outcomes where possible, either from this Unit or in combination with the Outcomes from the Unit *Gaelic (Learners): Understanding Language* (Higher). Evidence may also be gathered for individual Outcomes where appropriate.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
