UNIT Construction Operations: An Introduction to Installation of Ironwork Fixtures (SCQF level 5)

SUMMARY:

This Unit covers essential knowledge and practical experience relating to the installation and re-setting of ironwork fixtures in the construction environment. The Unit is suitable for candidates who have had little or no experience to date in the construction environment and who want to gain and apply knowledge and understanding of ironwork fixture installation and re-setting in the workplace environment. Candidates will safely prepare for, excavate and install ironworks fixtures. This will include adhering to Health and Safety regulations and legislation at all times. This Unit is suitable for candidates working towards a Modern Apprenticeship in the Construction Operative and Specialist suite.

OUTCOMES

- 1 Prepare for the installation of ironworks fixtures.
- 2 Excavate for installation of ironwork fixtures.
- 3 Install ironwork fixtures.

RECOMMENDED ENTRY

While entry to this Unit is at the discretion of the centre, candidates undertaking a National Progression Award at SCQF level 5, as part of a Modern Apprenticeship, must meet the necessary criteria which includes being employed in the relevant industry.

CREDIT VALUE

National Unit Specification: statement of standards

UNIT Construction Operations: An Introduction to Installation of Ironwork Fixtures (SCQF level 5)

Acceptable performance in this Unit will be the satisfactory achievement of the standards set out in this part of the Unit Specification. All sections of the statement of standards are mandatory and cannot be altered without reference to SQA.

OUTCOME 1

Prepare for the installation of ironworks fixtures.

Performance Criteria

- (a) Accurately interpret the given information to identify the works area.
- (b) Accurately identify ironwork installation requirements from the given instructions.
- (c) Correctly identify and select the ironwork fixture(s) as required by the work.
- (d) Correctly select tools, materials and equipment appropriate for the task.

OUTCOME 2

Excavate for installation of ironwork fixtures.

Performance Criteria

- (a) Select appropriate PPE equipment for a given task, in accordance with organisational requirements.
- (b) Correctly secure site for work to be carried out.
- (c) Accurately mark out the area to be excavated.
- (d) Correctly excavate for fitting the ironworks.

OUTCOME 3

Install ironwork fixtures.

Performance Criteria

- (a) Install correctly the selected ironwork fixtures.
- (b) Reinstate the surrounding excavation to required specifications.
- (c) Demonstrate the correct adherence to statutory requirements and/or safety notices and warning signs displayed in the workplace.
- (d) Dispose of waste in accordance with legislation.

EVIDENCE REQUIREMENTS

Candidates must carry out a risk assessment before any practical activity.

Evidence is required to demonstrate that candidates have achieved all Outcomes and Performance Criteria. The specific Evidence Requirements for each Outcome are outlined below.

Written and/or oral evidence is required to demonstrate that the candidates have achieved Outcomes 1 and 2. The evidence will be produced under open-book supervised conditions within a time limit of 30 minutes.

Performance evidence supplemented with an assessor observation checklist is required to demonstrate that candidates have achieved all of the Performance Criteria in Outcomes 1, 2 and 3. The evidence will be produced under supervised conditions at appropriate points in the Unit once candidates have developed the necessary knowledge and skills.

National Unit Specification: support notes

This part of the Unit Specification is offered as guidance. The support notes are not mandatory.

While the exact time allocated to this Unit is at the discretion of the centre, the notional design length is 40 hours.

GUIDANCE ON THE CONTENT AND CONTEXT FOR THIS UNIT

The content and context of this Unit is aimed at candidates who are interested in pursuing a career in construction. Candidates will be introduced to the installation of ironworks fixtures gain practical experience of that activity.

Throughout the Unit emphasis will be placed on the application of Safe Working Practices in line with current safety codes of practice, policies and regulations.

Centres may find opportunities to integrate this Unit with the mandatory Units.

Site conditions should reflect as near as possible realistic working conditions.

GUIDANCE ON LEARNING AND TEACHING APPROACHES FOR THIS UNIT

The learning environment for this Unit will be a combination of classroom and workshop based learning where the candidate will be involved in group activities and discussions. The knowledge element of this Unit would be taught in a classroom environment and put into practice in the workshop and also onsite in conjunction with the practical Outcomes.

Candidates could work in pairs or groups on the practical activity, although they will need to meet all Evidence Requirements individually.

OPPORTUNITIES FOR CORE SKILL DEVELOPMENT

Opportunities may arise in this Unit for candidates to develop aspects of the following Core Skills:

- ◆ *Communication* at SCQF level 3 by reading and interpreting information and work instructions
- ◆ *Numeracy* at SCQF level 3 by marking out
- ◆ *Working with Others* at SCQF level 3 by working in groups

GUIDANCE ON APPROACHES TO ASSESSMENT FOR THIS UNIT

Centres may use the instruments of Assessment which they consider to be most appropriate. It is expected that candidates will be given as much practise as possible in the methods of safe working practice and risk assessment methods etc, prior to being set the assessment tasks.

For Outcomes 1 and 2 a suitable method for assessing candidate knowledge and understanding of installation of ironwork fixtures could be through a set of multiple choice questions.

For all Outcomes to allow candidates to generate the Performance Evidence centres should set a series of practical assignments which accurately reflect the Unit content.

Opportunities for the use of e-assessment

E-assessment may be appropriate for some assessments in this Unit. By e-assessment we mean assessment which is supported by Information and Communication Technology (ICT), such as e-testing or the use of e-portfolios or e-checklists. Centres which wish to use e-assessment must ensure that the national standard is applied to all candidate evidence and that conditions of assessment as specified in the Evidence Requirements are met, regardless of the mode of gathering evidence.
