



## **Physics: Waves and Radiation (National 4)**

**SCQF:** level 4 (6 SCQF credit points)

Unit code: H25A 74

# Unit outline

The general aim of this Unit is to develop skills of scientific inquiry, investigation and analytical thinking, along with knowledge and understanding of waves and radiation. Learners will apply these skills when considering the applications of waves and radiation on our lives, as well as the implications on society/the environment. This can be done by using a variety of approaches, including investigation and problem solving.

The Unit covers the key areas of wave characteristics, sound, electromagnetic spectrum and nuclear radiation. Learners will apply scientific skills and communicate information related to their findings, which will develop skills of scientific literacy.

Learners who complete this Unit will be able to:

- 1 Apply skills of scientific inquiry and draw on knowledge and understanding of the key areas of this Unit to carry out an experiment/practical investigation
- 2 Draw on knowledge and understanding of the key areas of this Unit and apply scientific skills

This Unit is a mandatory Unit of the National 4 Physics Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given *in Unit Assessment Support*.

The Added Value Unit Specification for the National 4 Physics Course gives further mandatory information on Course coverage for learners taking this Unit as part of the National 4 Physics Course.

Entry to this Unit is at the discretion of the centre. However, learners would normally be expected to have attained the skills, knowledge and understanding required by one or more of the following or equivalent qualifications and/or experience:

National 3 Physics Course or relevant component Units

There may also be progression from National 3 Biology, National 3 Chemistry, National 3 Environmental Science, or National 3 Science Courses.

In terms of prior learning and experience, relevant experiences and outcomes may also provide an appropriate basis for doing this Unit.

## **Evidence Requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

The key areas covered in this Unit are:

- wave characteristics
- sound
- electromagnetic spectrum
- nuclear radiation

Evidence can be drawn from a variety of sources and presented in a variety of formats. The table below describes the evidence for the Assessment Standards which require exemplification. Evidence may be presented for individual Outcomes or gathered for the Unit as a whole, through combining assessment holistically in a single activity. If the latter approach is used, it must be clear how the evidence covers each Outcome.

Outcome 2: Making accurate statements and solving problems may be combined into one holistic assessment, with marks allocated to each question. In this case, to achieve Outcome 2 the candidate must achieve at least 50% of the marks available in the set of questions.

Outcome 1: Candidates must achieve at least five out of the six Assessment Standards to achieve a pass.

**Transfer of evidence:** evidence for the achievement of Outcome 1 for this Unit can be used as evidence of Outcome 1 in the *Electricity and Energy* and *Dynamics and Space* Units of this Course.

Where Assessment Standard 2.2 is being assessed separately from Assessment Standard 2.1, evidence of achievement of Assessment Standard 2.2 for this Unit can be used as evidence of achievement of Assessment Standard 2.2 in the *Electricity and Energy* and *Dynamics and Space* Units of the Course. **Note:** this does not apply when Outcome 2 is being assessed holistically.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through this Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
