Unit outline

The general aim of this Unit is to develop research skills and a basic knowledge and understanding of key aspects of developed and developing countries.

Learners who complete this Unit will be able to:

- 1 Use research skills in the context of developed and developing countries
- 2 Draw on their basic knowledge and understanding of human environments in developed and developing countries

This Unit is a mandatory Unit of the Access 3 Geography Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

Recommended entry

Outcomes and assessment standards

Outcome 1

The learner will:

1 Use research skills in the context of developed and developing countries by:

- 1.1 Collecting a limited range of basic geographical information about a developed and a developing country
- 1.2 Interpreting a limited range of basic geographical information in order to compare and/or contrast

If Units are being taken as part of a Course, then the evidence for 'mapping skills' and 'research skills' Outcomes may be presented in the context of *Geography: Physical Environment* or *Geography: Human Environment* Units.

Outcome 2

The learner will:

2 Draw on their basic knowledge and understanding of human environments in developed and developing countries by:

- 2.1 Outlining the main differences between a developed and a developing country
- 2.2 Describing, briefly, the factors influencing population change
- 2.3 Describing, briefly, land use in an urban or rural area

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Evidence can be drawn from a variety of sources and presented in a variety of formats, including brief written responses to questions, participation in group tasks, presenting information to other groups, and routine digital presentations. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit, Units or Course as a whole by combining assessment holistically in one single activity.

A limited range of geographical issues should be studied which demonstrate a contrast between a developed and a developing country. However, learners need only demonstrate achievement of Assessment Standards in one context.

A range of research skills may be developed in this Unit such as the use of: field work, field sketches, photographs, maps, graphs, secondary data, internet, and field work surveys.

Exemplification of assessment will be provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.
