## Unit outline

The general aim of this Unit is to develop a wide range of independent research skills. Learners who complete this Unit will be able to:

- 1 Develop independent research skills in the context of complex Classical Studies issues

## Outcomes and assessment standards

### Outcome 1

The learner will:

  - 1.4 Evaluating, analysing and synthesising evidence
  - 1.5 Understanding approaches to organising, presenting and referencing findings, using appropriate academic conventions

### Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards. Learners are required to demonstrate the skills in each of the Assessment Standards and teachers/lecturers must gather evidence of the attainment of these skills in appropriate ways.

This Unit requires the learner to develop a range of investigating skills. The Unit focuses on the processes involved in carrying out a major piece of research. Evidence for this Unit may be generated through a range of activities, such as:

- ◆ candidates' checklists/folios/logbooks
- ◆ interviews undertaken by the teacher/lecturer
- ◆ interim reports prepared while undertaking a piece of research
- ◆ presentations by the candidate to the teacher/lecturer or to other learners

The teacher/lecturer may use a checklist during learners' interviews or presentations. The evidence may be collected and retained in a variety of forms including written records and audio or digital recordings.

Evidence may be presented for individual Assessment Standards or gathered for the Unit as a whole by combining assessment holistically.

Exemplification of assessment is provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
