Unit outline

The general aim of this Unit is to critically analyse questions from the philosophy of religion and different responses to them. Learners will develop factual and abstract knowledge and understanding of the area.

Learners who complete this Unit will be able to:

- 1 Apply in-depth knowledge and understanding of a question from the philosophy of religion
- 2 Critically analyse a question from the philosophy of religion, and responses to it

This Unit is a mandatory Unit of the Higher Religious, Moral and Philosophical Studies Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

The Course Assessment Specification for the Higher Religious, Moral and Philosophical Studies Course gives further mandatory information on Course coverage for learners taking this Unit as part of the Higher Religious, Moral and Philosophical Studies Course.

Outcomes and assessment standards

Outcome 1

The learner will:

- 1 Apply in-depth knowledge and understanding of a question from the philosophy of religion by:**
 - 1.1 Explaining the question, in detail and describing the abstract concepts involved
 - 1.2 Identifying the key points and implications of the question, using abstract concepts appropriately

Outcome 2

The learner will:

- 2 Critically analyse a question from the philosophy of religion, and responses to it, by:**
 - 2.1 Explaining and comparing, in detail and using abstract concepts appropriately, a religious response to the question and a response from science and/or philosophy
 - 2.2 Explaining, in detail and using abstract concepts appropriately, possible strengths and weaknesses of the religious response and the response from science and/or philosophy
 - 2.3 Explaining, in detail and using abstract concepts appropriately, the potential impact(s) of the different responses on people's lives
 - 2.4 Presenting a coherent conclusion on the question and responses, with a reasoned justification referring to supporting evidence

Evidence Requirements for the unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Evidence can be drawn from a variety of sources and presented in a variety of formats, including written responses to questions, participation in group tasks, presenting information to other groups, and digital presentations.

The evidence does not need to come from one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit or Course as a whole by combining assessment holistically in one single activity.

The Outcomes and Assessment Standards require learners to answer in the context of one question from the philosophy of religion, one response from religion and one response from

science and/or philosophy. However, it is the expectation that good quality teaching will normally cover a wider range than the minimum required to pass the Unit assessment.

All Assessment Standards in this Unit may be assessed by studying a single question and responses.

Religious responses studied must come from one of the world's six major religions (Christianity, Buddhism, Hinduism, Islam, Judaism or Sikhism).

Exemplification of assessment will be provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.
