**Unit title:** Global Economic Activity (Higher)

## Unit outline

The general aim of this Unit is to enable learners to analyse the global nature of economics. Learners will explore global trade and the balance of payments and their importance in the UK economy. They will also examine the floating exchange rate system. Lastly, learners will consider economic features of the European Union, developing countries and emerging economies.

Learners who complete this Unit will be able to:

- 1 Assess how global trade and the global economy affect the UK economy
- 2 Analyse the UK balance of payments and exchange rate systems

This Unit is a mandatory Unit of the Higher Economics Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

The Course Assessment Specification for the Higher Economics Course gives further mandatory information on Course coverage for learners taking this Unit as part of the Higher Economics Course.

## Recommended entry

Entry to this Unit is at the discretion of the centre. However, learners would normally be expected to have attained the skills, knowledge and understanding required by one or more of the following or equivalent qualifications and/or experience:

- ◆ Economics (National 5) Course or relevant component Units
- ◆ Higher Business Management Course

Examples of other such relevant prior learning and experiences would involve an interest in the economy and/or current affairs.

## Outcomes and assessment standards

### Outcome 1

The learner will:

- 1 Assess how global trade and the global economy affect the UK economy by:**
  - 1.1 Explaining why countries choose to specialise and trade with each other, detailing the costs and benefits of doing so
  - 1.2 Explaining the consequences that the growth in developing or emerging economies may have on the UK economy
  - 1.3 Describing how economic change to the European Union impacts on the UK economy
  - 1.4 Describing how recent import and export patterns in the UK affect the UK economy

### Outcome 2

The learner will:

- 2 Analyse the UK balance of payments and exchange rate systems by:**
  - 2.1 Describing an exchange rate system used in the UK and its affect on the UK balance of payments
  - 2.2 Identifying and describing items on the current account and capital account of the balance of payments
  - 2.3 Explaining measures that the UK Government may use to address imbalances on the current account

## Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence can be drawn from a variety of sources and presented in a variety of formats including short written responses and/or recorded oral evidence. Learners should use appropriate economic terminology at all times in their responses and include, where appropriate, the use of relevant examples.

Evidence may be presented for individual Outcomes or it may be gathered for the Unit as a whole through integrating assessment holistically in one single activity. If the latter approach is used, it must be clear how the evidence covers each Outcome.

Exemplification of assessment will be provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.
