**Unit title:** Modern Studies: Social Issues in the United Kingdom (Higher)

## Unit outline

The general aim of this Unit is to develop learners' skills of evaluating a range of written, numerical and graphical sources of information in order to make and justify decisions in the context of social issues. Learners will draw on their knowledge and understanding of social issues within the United Kingdom and Scotland.

Learners who complete this Unit will be able to:

- 1 Research and use a wide range of sources of information to make and justify decisions about social issues in the United Kingdom
- 2 Draw on their knowledge and understanding of social issues in the United Kingdom

This Unit is a mandatory Unit of the Higher Modern Studies Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

The Course Assessment Specification for the Higher Modern Studies Course gives further mandatory information on Course coverage for learners taking this Unit as part of the Higher Modern Studies Course.

Entry to this Unit is at the discretion of the centre. However learners would normally be expected to have attained the skills, knowledge and understanding required by one or more of the following or equivalent qualifications and/or experience:

## Outcomes and assessment standards

### Outcome 1

The learner will:

- 1 Research and use a wide range of sources information to make and justify decisions about social issues in the United Kingdom by:**
  - 1.1 Identifying and collecting at least two sources of information, most of which are complex, including sources which may be written, numerical, graphical or pictorial, related to a social issue in the United Kingdom
  - 1.2 Synthesising and evaluating information, from between two and four sources of information, most of which are complex, in order to make and justify a decision about a social issue in the United Kingdom
  - 1.3 Evaluating evidence which may be used to support an alternative decision

### Outcome 2

The learner will:

- 2 Draw on their knowledge and understanding of social issues in the United Kingdom by:**
  - 2.1 Giving detailed descriptions and explanations of a social issue in the United Kingdom which draw on factual and theoretical knowledge and understanding
  - 2.2 Analysing a complex social issue in the United Kingdom

## Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

If the Unit is being taken as part of the Higher Modern Studies Course, centres may wish to generate evidence in a way which prepares learners for the Course assessment. Assessment evidence can be drawn from a variety of sources and presented in a variety of formats, including written responses to questions, a report of a decision making exercise, participation in group tasks, presenting information to other groups, and digital presentations. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit or Course as a whole by combining assessment holistically in one single activity.

Exemplification of assessment will be provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.
