Unit title: Care: Social Influences (National 5)

SCQF: level 5 (6 SCQF credit points)

Unit outline

The general aim of this Unit is for the learner to develop an understanding of the process of socialisation and the ways in which wider social influences can impact on individuals and groups in society. Learners will gain an understanding of inequality and investigate ways in which to challenge inequality experienced by service users.

Learners who complete this Unit will be able to:

- 1 Investigate social influences in two cultures
- 2 Investigate ways to promote equality and diversity for service users

This Unit is a mandatory Unit of the Care (National 5) Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provides advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

Recommended entry

Entry to this Unit is at the discretion of the centre. However, learners would normally be expected to have attained the skills, knowledge and understanding required by one or more of the following or equivalent qualifications and/or experience:

Outcomes and assessment standards

Outcome 1

The learner will:

1 Investigate social influences in two cultures by:

- 1.1 Using sociological concepts to describe socialisation
- 1.2 Investigating socialisation in two different cultures
- 1.3 Comparing socialisation in two different cultures

Outcome 2

The learner will:

2 Investigate ways to promote equality and diversity for service users by:

- 2.1 Using sociological concepts to describe why inequality exists
- 2.2 Explaining the impact of inequality on a group of service users
- 2.3 Investigating two things that have been done in society to promote equality and diversity for this group

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Further guidance on Assessment Standards:

- 1.1 'sociological concepts' could include norms, roles, status, culture, sub-culture, primary/secondary socialisation, agents of socialisation.
- 2.1 'sociological concepts' could include labelling, power, conflict, stratification, consensus, dysfunctional, prejudice, stereotype, discrimination.
- 2.2 The candidate may receive guidance and support from the teacher/lecturer as appropriate when choosing the group of service users to be investigated. This may take the form of a providing a case study or other prompts.

Assessment evidence can be drawn from a variety of sources and presented in a variety of formats. The evidence does not need to be achieved in one activity, but can be assembled from a variety of tasks and assessments carried out throughout the Course. Evidence may be presented for individual Outcomes or gathered for the Unit or Course as a whole by combining assessment holistically in one single activity.

Exemplification of assessment will be provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
