## Unit outline

The general aim of this Unit is to develop the learner's skills in evaluating historical sources. Learners will apply knowledge and understanding of important events and themes within a specific context of Scottish history.

Learners who complete this Unit will be able to:

- 1 Use a range of straightforward historical sources and evaluate their usefulness
- 2 Draw on a straightforward factual knowledge and understanding of important historical events

This Unit is a mandatory Unit of the History (National 5) Course and is also available as a free-standing Unit. The Unit specification should be read in conjunction with the *Unit Support Notes* which provides advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

## Recommended entry

Entry to this Unit is at the discretion of the centre. However, learners would normally be expected to have attained the skills, knowledge and understanding required by one or more of the following or equivalent qualifications and/or experience:

- ◆ History (National 4) or relevant component Units
- ◆ Literacy (SCQF level 4)

In terms of prior learning and experience, relevant experiences and outcomes may also provide an appropriate basis for doing this Unit. Further information on relevant experiences and outcomes will be given in the *Unit Support Notes*.

  - 1.2 Providing a straightforward conclusion on the usefulness of at least two sources of information
  - 1.3 Taking into account content and context by applying appropriate recall of straightforward information

### Outcome 2

The learner will:

- 2 Draw on a straightforward factual knowledge and understanding of important historical events by:**
  - 2.1 Outlining, in detail, and with some accuracy, important historical events
  - 2.2 Explaining, in detail, important historical events

## Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Sources can be either primary or secondary and at least two must be used, although there is no recommended upper limit. Evidence can be presented in a variety of formats, including participation in group tasks, presenting information to other groups, simple digital presentations and detailed written responses to questions. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit or Course as a whole by combining assessment holistically in one single activity.

Exemplification of assessment will be provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
