Unit outline

In this Unit, learners will investigate a range of contemporary food issues in Scotland. They will analyse how these issues influence decisions taken by consumers when making food choices.

Evidence Requirements for the Unit

For this Unit, learners will be required to investigate a contemporary food issue in Scotland. These issues could include, but are not limited to, ethical, environmental, economic, social or cultural issues. Learners will communicate their findings in an appropriate way.

Learners will be required to provide evidence of:

Using a range of investigative techniques to obtain information about the issue.
These could include surveys, interviews, literature searches or any other appropriate technique.

It must be clear how the evidence covers each Assessment Standard, and additional evidence must be provided if one or more standards have not been assessed.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
