

How can the SCQF help your business?

The SCQF may help you to:

Compare the different qualifications of applicants:

With the range of qualifications available, it can be difficult to decide which is the most appropriate for the job. The SCQF helps you to compare the qualifications of applicants.

Develop your workforce and avoid costly training mistakes:

The SCQF can help you to plan on-going training and development for all your staff by using the Framework as a reference point for qualifications and learning when selecting appropriate training programmes.

Gain credit for your in-house training programmes:

If you are an employer and interested in having an in-house training programme credit-rated, you can contact:

As an employer can you relate to this?

The **Scottish Credit and Qualifications Framework (SCQF)** is designed to help both employers and learners understand and compare the range of qualifications available in Scotland.

It does this by giving qualifications a **level** and **credit** points. The Framework has 12 levels – ranging from National Qualifications at Access Level 1 up to Doctorate at Level 12.

As you can see from the table, the **level** of a qualification shows how difficult the learning is. When two qualifications are at the same level it means that they have the same level of difficulty.

Credit points are simply a way of describing the amount or volume of learning – of knowledge, skills or competence needed to achieve the qualification.

The SCQF diagram shows the mainstream qualifications offered by the Scottish Qualifications Authority (SQA), colleges and universities. As more qualifications are credit rated, they will be added to the Framework. These will include the SQA’s new National Qualification Group Awards (National Certificates and National Progression Awards) and Professional Development Awards. Details of the full range of available qualifications are available on the websites of SQA, universities and colleges. The SCQF allows you to compare the new qualifications to those with which you are more familiar.
