Unit outline

The general aim of this Unit is to develop learners' basic language skills in understanding information in the optional language. Learners will also communicate in the optional language.

- 1 Show understanding of simple words and/or phrases in the optional language.
- 2 Interact with another user of the optional language.

Outcome 2

The learner will:

- 2 Interact with another user of the optional language by:**
 - 2.1 Making relevant contributions to an interaction in a personal context
 - 2.2 Making relevant contributions to an interaction in a transactional context

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence may be presented for individual Outcomes or it may be gathered for the Unit as a whole through integrating assessment for both Outcomes. If the latter approach is used, it must be clear how the evidence covers each Outcome.

For Outcome 1, evidence is required which demonstrates the learner's identification of at least four simple words and/or phrases in the context of personal language, and at least four simple words and/or phrases in the context of transactional language. This means learners will identify at least eight simple words and/or phrases in total.

For Outcome 2, evidence is required which demonstrates the learner's ability to make at least four relevant contributions to at least one interaction in a personal context and at least four relevant contributions to at least one interaction in a transactional context. This means learners will make at least eight contributions in total.

It is expected that learners will receive support to achieve the Outcomes of this Unit.

For this Unit, evidence could include audio and/or audio-visual files recorded on CD and/or DVD, printed materials, observation checklists, logs, recorded oral responses, photographic evidence, video evidence, or their equivalent. Assessors should be confident that there is sufficient evidence to support their judgement that the Assessment Standards have been met. Evidence may be gathered using the learner's usual means of communication.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
