## National Qualifications — Art and Design

### 1 Art and Design Appeals 2007

SQAs' recently updated *Estimates, Absentees and Assessment Appeals: Guidance on Evidence Requirements* document is where teachers will find clarified information about generating evidence requirements for Absentee and Appeals consideration.

Centres are advised to pay particular attention to the Art and Design subject specific pages of this document. These pages outline the exact evidence requirements for Appeals for each level of the NQ Courses.

In addition, the January 2007 Update Letter also gives information and guidance about Appeals.

Please note that for Intermediate 2 and Higher levels, an Appeal is for the overall Course award. The generation of alternative evidence for the practical component is not mandatory (although perfectly acceptable if available) but the evidence for the question paper is mandatory.

The following is a table of information about gathering evidence for Appeals for all levels.

## **3 SQA Art Exhibition at the National Gallery of Scotland**

An exhibition of top range Standard Grade, Intermediate and Higher artwork will be displayed in the National Gallery of Scotland, Edinburgh from 24 October 2007 until 4 January 2008. The display will consist of over 100 pieces of framed expressive artwork alongside 3D design work from candidates throughout Scotland. Fully illustrated catalogues for teachers and candidates will be available to support the Exhibition.

Thanks to sponsorship a 'travel grant' scheme will be available to assist schools and colleges meet the travel costs of taking candidates to the Exhibition. Full details of the scheme and how to book visits to the Exhibition will be issued in mid August.

In addition the National Gallery of Scotland will be hosting teacher workshops in November free of charge. On 3 November Caroline Earl will deliver two half day events on mixed media. Milliner, Felicity Faichney will deliver a full day session on 10 November. Further information about both workshops and how to reserve places will be issued by the National Gallery of Scotland shortly.
