# Develop and implement marketing plans for your area of responsibility



---

### Overview

This unit is about developing and implementing marketing plans for your area of responsibility. This unit describes the classic model of marketing planning, implementation and control, which can be adopted by managers who do not have specialist marketing expertise.

The unit is recommended particularly for middle managers who, as part of their role, are required to develop marketing plans for their area of responsibility. It is not aimed at specialist marketing managers who should refer to the Marketing National Occupational Standards.

#### Performance criteria

- You must be able to:*
- P1 identify and prioritise marketing objectives for your area of responsibility that are consistent with your organisation's overall business plan, culture, vision and values and take into account the needs of other areas of the organisation
  - P2 obtain advice and support from marketing specialists and those providing marketing services, as required
  - P3 identify the target markets for your products and services and develop appropriate strategies for realising marketing objectives
  - P4 develop and agree marketing plans and budgets for the achievement of the strategies, setting out clear actions, risks, contingencies, accountabilities and milestones
  - P5 identify and access the resources and capabilities required for your plans
  - P6 ensure that those implementing the marketing plan understand their individual responsibilities and are committed to achieving objectives
  - P7 exercise flexibility while implementing the plan as agreed and within budget
  - P8 implement the plan as agreed whilst exercising flexibility
  - P9 monitor and report on the implementation and performance of the plan against milestones and budgets
  - P10 take timely and appropriate action to address any significant variances in performance against the plan
  - P11 evaluate the implementation of the marketing plan and use the information to improve future marketing planning

- K11 the importance of taking timely and appropriate action to address any significant variances in performance against the plan, and how to do so effectively
- K12 the importance of identifying ways in which future marketing planning can be improved
- K13 how to develop and implement measures and methods for evaluating the implementation of the marketing plan
