General Update

Internal Assessment Reports (IARs)

IARs provide an annual summary of visiting and central verification activity in relation to HN Qualifications. Reports are currently in production for each of the subject areas and are currently being processed by SQA. They will be published in due course and placed on the relevant HN subject page under 'subject specific information'.

HN Network Support Events

Feedback from the 2016 annual Network Support Events continues to be positive with delegates highlighting the importance of being able to meet practitioners from across the sector. It is therefore our intention to host events for the Accounting, Administration and Information Technology and Business HNs in early 2017. We will notify centres of dates and the process for booking places towards the end of this year.

HN Survey

Thank you again to all centres who participated in the 5th annual HN surveys. These surveys acquire feedback from both practitioners and learners, and are a valuable means by which to inform future qualification developments and projects. The responses will be summarised and presented for discussion at the next Qualification Support Team (QST) meeting.

Formative Assessments

An instance of a live SQA Assessment Support Pack (ASP) being used as a formative assessment was identified during this year's central verification activity. Centres are reminded all SQA published ASPs must remain secure and must only be used for summative assessment purposes. The shell publication document for SQA published ASPs has now been updated to include a statement to this effect. In addition, this statement has been added to the 'Browse HN Sectors' page on the SQA secure site and to the Support Materials pages on the open SQA website.

A range of formative assessments for HN Accounting, Administration and Information Technology and Business are available on the SQA Secure website for use as preparation and practice assessment. These assessments were adapted from Assessment Exemplars for HN Units which have now ended and therefore may not map fully to the content of current Units, but should still provide useful preparation for learners.

HN Accounting

We have now completed Phase 2 of our project to update the Unit specifications and ASPs to comply with Accounting Standard FRS 102. Details of revisions are detailed below.

A new Assessment Support Pack (ASP) has been commissioned for **Income Tax (F86X 35)**. The anticipated publication date is October 2016.

Plans for 2016/17

It is in our plans for 2016/17 to revise the Unit specification and ASP for **Recording Financial Information (F7JV 34)** to bring them into line with HMRC legislation relating to Prompt Payment Discounts (PPD) and VAT. As the change came into effect on 1 April 2015, centres may use the ASPs as they stand or can amend them to take account of the amended legislation. Centres should record any amendments in their Internal Verification records. The External Verification Team has been advised of this arrangement.

HN Administration and Information Technology

The limited review of the HNC/D Administration and Information Technology Group Awards is well underway. Two Qualification Review Team (QRT) meetings have taken place and work is ongoing on revisions to some of the Units. These revisions were informed by consultation in late 2015-early 2016, feedback from the 2016 Network Support Events and the 2015 and 2016 annual surveys. Changes have yet to be finalised, however an outline of the forthcoming changes is provided in the table below:

Recent revisions to Accounting Units have had a minor knock-on effect to content within the HND Business Group Awards. The impact is largely superficial and outlined below.

Business Accounting (F84M 34)

The ASP F84M/AEX001 and supplementary material for Outcomes 3, 4 and 5 have been revised to include Statements of Changes in Equity (SOCIE). Although the SOCIE is not required to complete the assessment task, the inclusion of the SOCIE will provide clarity for lecturers and students. Please refer to the History of Change section within these publications for more detail.

SQA plan to revise the second ASP for this Unit (F84M 34/AEX002) to comply with FRS 102 during 2016/17.

Preparing Financial Forecasts (F84R 35)

This Unit specification and ASP have been revised to comply with FRS 102. The changes are very minor.

Business: Graded Unit 2 (F8LE 35)

No revisions were made to either the Unit specification or the ASP as they were not affected by FRS 102.
