

## SQA Care SVQ Mapping Exercise

## SVQ Care Services Leadership and Management SCQF level 10 and SVQ Social Services Healthcare SCQF level 9

SQA recognises that there are some significant areas of commonality between some of the units in these awards. These units have a similar or identical title but they will have a different SQA unit code and sometimes a different SCQF level and number of SCQF credit points attached. This means that candidates who undertake both qualifications cannot be given automatic credit for similar units achieved in the other qualification.

This mapping exercise has been designed to assist assessors and candidates to identify the units where there is a significant similarity in the performance and knowledge points that require to be evidenced. This information can then be used to enable the assessor to plan with the candidate how to meet the evidence requirements of the awards in an efficient and effective way.

It does not guarantee that the evidence produced by the candidate for one qualification will *automatically* provide evidence for the other qualification. The intention is to signpost the candidate to where they may already have gathered evidence that meets the requirements of the other award.

Candidates are still required to annotate their work in the relevant part of the text with the performance criteria and knowledge points for the discrete qualifications. Assessors are still required to make the assessment decision about whether the points have been met sufficiently.

There are four units within both qualifications which are identical except for the SQA code. Where a candidate has achieved one of these units in one qualification they can be registered and resulted for the identical unit in the other qualification.
