



# **Environmental Science: Sustainability with a Scottish Context (National 4)**

**SCQF:** level 4 (6 SCQF credit points)

Unit code: H6N8 74

# Unit outline

The general aim of this Unit is to develop skills of scientific inquiry, investigation and analytical thinking, along with knowledge and understanding sustainability. Learners will apply these skills when considering the applications of sustainability on our lives, as well as the implications on society/the environment. This can be done by using a variety of approaches, including investigation and problem solving.

The Unit covers the key areas of: the sustainability of key natural resources and possible implications for human activity in Scotland, the interaction between humans and the environment and the impact of human activity on an area of Scotland, the role of agriculture in the production of food and raw material in Scotland and its environmental impacts and sustainability, Scotland's energy needs, and the impact of developments in transport infrastructure in a selected area of Scotland and development of sustainable systems. Learners will research issues, apply scientific skills and communicate information related to their findings, which will develop skills of scientific literacy.

Learners who complete this Unit will be able to:

- Apply skills of scientific inquiry and draw on knowledge and understanding of the key areas of this Unit to carry out an experiment/practical investigation
- 2 Draw on knowledge and understanding of the key areas of this Unit and apply scientific skills

This Unit is an alternative mandatory Unit of the National 4 Environmental Science Course, an optional Unit in the Scottish Studies Award at SCQF level 4 and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work.

The Added Value Unit Specification for the National 4 Environmental Science Course gives further mandatory information on Course coverage for learners taking this Unit as part of the National 4 Environmental Science Course.
