



Social Subjects: Organising and Communicating Information (Alternative Context) National 2

This Unit should only be used where a learner has already achieved the original Unit, which carries the same title but without the “Alternative Context” suffix. There should be at least one year between the delivery of the original Unit and the delivery of the “Alternative Context” version.

The alternative context could relate to the delivery setting, the maturity of the learner or the activities the learner is asked to complete.

Unit outline

The general aim of this Unit is to enable learners to organise and communicate information about a context they have studied within the social subjects (Geography, History, Modern Studies, and Classical Studies) and/or religious and moral education curriculum areas. The form of communication used may vary according to personal choice and the availability of resources. Examples of forms of communication may include: a poster, a sequence of photographs, a wall display, or an aural recording or short film.

Learners who complete this Unit will be able to:

- 1 Organise information
- 2 Communicate information

This Unit is a mandatory Unit of the National 2 Social Subjects Course and is also available as a free-standing Unit.
