Unit outline

This 'Healthy Eating' Unit at SCQF level 1 is part of the Personal Achievement Award suite of Units.

The general aim of this Unit is to provide opportunities for the learner to develop their skills, knowledge, and understanding about healthy eating. Activities could include: basic cookery, developing a personal health plan, or finding out about healthy foods.

Learners who complete this Unit will be able to:

- 1 Prepare for an activity involving healthy eating
- 2 Participate in an activity involving healthy eating
- 3 Give an opinion about participating in the activity

This Unit is an optional Unit of the Personal Achievement Award (SCQF level 1) and is also available as a free-standing Unit.
