Unit outline

This 'Looking after your Home' Unit at SCQF level 1 is part of the Personal Achievement Award suite of Units.

The general aim of this Unit is to provide opportunities for the learner to look after an aspect or aspects of their home. Activities could include: generally caring for the home, simple home repairs, or home decorating.

Learners who complete this Unit will be able to:

- 1 Prepare for an activity involving looking after your home
- 2 Participate in an activity involving looking after your home
- 3 Give an opinion about participating in the activity

This Unit is an optional Unit of the Personal Achievement Award (SCQF level 1) and is also available as a free-standing Unit. The *Unit Specification* should be read in conjunction with the combined Award *and Unit Support Notes*, which provides advice and guidance on delivery, assessment approaches, and development of skills for learning, skills for life, and skills for work.
