Unit outline

This 'Personal Health' Unit at SCQF level 1 is part of the Personal Achievement Award suite of Units.

The general aim of this Unit is to provide opportunities for the learner to develop their understanding of the importance of, and reasons for, personal health. Activities could include: participating in a fitness and exercise programme, taking part in a relaxation technique, or developing a personal health plan.

Learners who complete this Unit will be able to:

- 1 Prepare for an activity involving personal health
- 2 Participate in an activity involving personal health
- 3 Give an opinion about participating in the activity

This Unit is an optional Unit of the Personal Achievement Award (SCQF level 1) and is also available as a free-standing Unit.
