Unit outline

This 'Promoting Health' Unit at SCQF level 1 is part of the Personal Achievement Award suite of Units.

The general aim of this Unit is to provide opportunities for the learner to develop an understanding about the importance of promoting health within a community context. Examples of how this Unit could be developed include taking part in a project designed to promote health or preparing a poster for a community or centre context.

Learners who complete this Unit will be able to:

- 1 Prepare for an activity involving promoting health
- 2 Participate in an activity involving promoting health
- 3 Give an opinion about participating in the activity

This Unit is an optional Unit of the Personal Achievement Award (SCQF level 1) and is also available as a free-standing Unit.
