1	<ul> <li>(a) Identify and locate livestock which are to be re-located, in line with instructions received.</li> <li>(b) Check livestock destinations and routes before livestock are moved and take remedial action to correct problems.</li> <li>(c) Report livestock showing any signs of injury, stress, abnormal physical condition or behaviour to the relevant person.</li> <li>(d) Identify how you would deal with any problems which may arise before approaching livestock.</li> <li>(e) Identify livestock needing isolation to the relevant person.</li> </ul>		
	Move livestock This means you:	Evidence of moving livestock in accordance with workplace procedures.	
2	<ul> <li>(a) Approach livestock in a calm, confident manner and move them at a suitable pace from the holding area without causing injury and minimal stress.</li> <li>(b) Monitor the livestock's behaviour and control their movement to ensure the livestock reach their destination safely.</li> <li>(c) Ask for help immediately when there are difficulties in moving the livestock.</li> <li>(d) Restrain livestock safely and correctly in line with instructions.</li> <li>(e) Re-locate livestock safely to the correct destination at the end of the procedure.</li> </ul>
