Section 2: Comments on assessment

Assessment approaches

The evidence submitted from centres was well organised and of a high standard. There was a mixture of complete and interim evidence and this was all clearly marked on the flysheets.

Some centres delivering units at National 2 level utilised the unit assessment support packs to assess their candidates and this ensures that all assessment standards are covered and met. There was an increase, however, in the number of centre-produced assessments. These creative and innovative assessments clearly showed that coursework had been developed to meet the individual and diverse needs of candidates. Centres had used guidance and suggested activities from the judging evidence tables to clearly demonstrate how their assessments had been developed and adapted to meet individual candidate needs.

Centres using National 1 units produced appropriate, individualised and well labelled assessments. These frequently were enhanced with photographic evidence, supporting assessor comments and informative details regarding the amount and type of support given to candidates.

Most centres completed and included candidate assessment record sheets to record achievements and successes. These included detailed and informative assessor comments, dates of when assessments were undertaken, and the assessors' judgements on whether the work was a pass or fail.

Assessment judgements

The majority of centres were seen to be applying the standards to assessments and showed that they had a sound knowledge of national standards and procedures. There was clear evidence that centres are making reliable and consistent judgements when assessing candidates. The evidence submitted was generally of a high standard.

A few centres submitted interim evidence and indicated that their candidates had failed the coursework. Incomplete evidence should not automatically mean it is a

fail but the assessment judgement should reflect the expected result once all the assessments have been completed.

Candidate assessment records and checklists were used effectively. The assessment records and checklists submitted were clear and included an abundance of relevant information on activities undertaken, including candidate responses and actions, comments on how judgements had been made, and other assessor comments.

Centres continue to include photographic evidence to support and enhance their evidence. These were accompanied by assessor comments and matched with outcome and assessment standard numbers making these photographs relevant and informative. This year one centre submitted its photographic evidence on a memory stick rather than printing out all their photographs. This meant more pictures could be submitted and this method was well received by the external verifiers.

Detailed assessor comments throughout candidate evidence, on candidate assessment records and on checklists, clearly showed how judgements had been reached and this is good practice.

Section 3: General comments

It is important that all centres detail the additional support given to candidates on the flysheet and on any candidate evidence as appropriate, eg scribe, reader, physical support, prompting.

Assessment judgements should be included for each candidate and noted on the Verification Sample Forms and on candidate assessment records. These should be a pass or fail. Accompanying comments can help clarify how these decisions have been reached.

It is good practice to include candidate assessment records and any logs and checklists used to show how assessment judgements have been made.

Some centres provided excellent examples of their internal verification policies, procedures and practices. There was evidence of cross-marking, constructive feedback to assessors and candidates, and relevant suggestions. A few centres showed little evidence of internal verification having taken place and were advised to refer to the website www.sqa.org.uk/IVtoolkit for further information and support. It is important that centres have an effective internal quality assurance system in place and that evidence of the application of such processes is included for external verification.
