Co-ordinate the provision of water for crops or plants

Overview

This standard is for those whose work role is to co-ordinate the provision of water to crops or plants outdoors or in protected conditions.

This standard covers the coordination of your own work load, it may in some instances involve coordinating the work of teams.

You will require considerable knowledge of the principles of plant growth and development and plant health.

 - P3 inspect plants and assess the need for the provision of water
 - P4 check and confirm that the supply of water to the plants is in accordance with specifications
 - P5 identify the need for adjustments to watering systems in accordance with specifications
 - P6 ensure adjustments to watering systems are in accordance with the requirements of the plants
 - P7 ensure equipment is used and maintained in a safe and effective condition
 - P8 ensure appropriate records are completed as required by relevant legislation and the organisation
 - P9 your responsibilities under current environmental and health and safety legislation, codes of practice and company policies
