- P12 manage health records in accordance with legal and site Fish Health Plan (FHP) requirements

#### Glossary

**Fish Health Plan (FHP)** – also referred to as Veterinary Health Plan (VHP) and Veterinary Health and Welfare Plan (VHWP)

**prophylactic** – preventative treatment e.g. vaccination

**resources** – people, equipment, storage, transport
