
Overview

This standard identifies the competences you need to prepare yacht or boat substrates (such as wood, metals, ceramic, compliant rubber/polymer, plastics) to enable coating systems to be applied, in accordance with approved procedures. You will be required to carry out preparation on a variety of substrates, using both hand and mechanical tools, including the use of chemical paint strippers where required. The process will also include degreasing using solvents and cleaning the surface prior to the application of the coatings.

Your responsibilities will require you to comply with organisation policy and procedures for the preparation activities undertaken and to report any problems with the preparation activities that you cannot personally resolve, or are outside your permitted authority, to the relevant people. You will be expected to work with a minimum of supervision, taking full responsibility for your own actions and for the quality and accuracy of the work that you carry out.

Your underpinning knowledge will provide a good understanding of your work and will provide an informed approach to applying preparation procedures to yacht or boat component surfaces. You will understand the preparation procedures, their application and relevant standards, in adequate depth to provide a sound basis for carrying out the activities to the required specification.

You will understand the safety precautions required when carrying out the preparatory operations. You will be required to demonstrate safe working practices throughout and will understand the responsibility you owe to yourself and others in the workplace, both ashore and afloat.

Performance criteria

You must be able to:

- P1 work safely at all times, complying with health and safety legislation, regulations, directives and other relevant guidelines
- P2 obtain and follow relevant instructions, standards and other specifications
- P3 identify the conditions of the surface to be prepared
- P4 select the appropriate tools and equipment and check that they are in a safe and usable condition
- P5 carry out the preparation activities using appropriate tools and techniques
- P6 check the prepared surface to ensure that it meets the required specification
- P7 deal promptly and effectively with problems within your control and report those that cannot be resolved
- P8 shut down and secure the preparation equipment to a safe condition on completion of the activities
- P9 reinstate the work area on completion of the activities, in line with agreed organisational procedures

Preparing yacht and boat surfaces for coating/finishing using hand and mechanical tools

Knowledge and understanding

You need to know and understand:

- K1 the safe working practices and procedures to be observed when working with hand and mechanical surface preparation tools (such as general workshop and site safety, protecting other workers from the effects of the work, safety in enclosed/confined spaces, working at height, use of mobile elevated work platforms (MEWPs), atmospheric controls)
- K2 how to recognise and deal with emergencies and the procedures to be followed (such as methods of safely evacuating and closing down of compartments in the case of fire or other major incident, first aid, fire fighting and resuscitation of personnel)
- K3 statutory requirements, risk assessment procedures and relevant requirements of HASAWA and COSHH (such as The Management of Health and Safety at Work Regulations, The Provision of and Use of Work Equipment Regulations, The Noise at Work Regulations, Control of Vibration at Work Regulations, The Confined Spaces Regulations, The Special Waste Regulations, The Pollution Prevention and Control Regulations, the Water Resources Act)
- K4 the environmental impact of the operations you are carrying out and with the materials that are used and how the impact can be minimised
- K5 the health and safety requirements of the work area in which you are carrying out your surface preparation activities and the responsibility they place upon you
- K6 the hazards associated with carrying out surface preparation activities on yacht or boats and with the materials and equipment used, (such as dust/debris, hearing damage, hand/arm vibration, working at heights) and how they can be minimised
- K7 the requirements for working in confined spaces and the importance of emergency procedures and safe systems of work (including permits to work, Required Air Quantities (RAQs) and local exhaust ventilation (LEV)) to maintain safe conditions; the provision of adequate and safe lighting and avoidance of sources of ignition
- K8 how particular procedures, cleaning materials and arisings can result in a compartment or space (such as an accommodation space or tented enclosure) becoming a confined space
- K9 the importance of having regular medical examinations when using vibrating tools, solvent based materials, or when exposed to hazardous arisings
- K10 the personal protective equipment (PPE) to be worn during the surface preparation activity and its care and correct use
- K11 how to obtain the required work procedures, specifications and instructions and how to interpret their requirements

- K12 the reasons for carrying out surface preparation and the effects on the final finishing activities if preparations are not carried out correctly
- K13 the various types of substrate that may require preparing and the types of tools and preparation methods that may be used on them
- K14 the damage that may result from using inappropriate tools and techniques
- K15 why different types of substrate require different preparation techniques to be used
- K16 the types of defects and contamination to be found on unpainted and painted surfaces and their causes
- K17 how to identify defects in deck screeds and deck coverings and the methods used to remove them
- K18 types of tools and equipment used for the surface preparation activities (to include setting up and safe operation, compatibility of the power tools and wheels, checking air supplies and hoses for leaks and for contamination, safety arrangements and guards, manufacturers' operating instructions, and techniques for using them)
- K19 the importance of the maintenance of a register of power tools and the need to check tools against certification
- K20 quality control techniques and procedures used during the preparation activities and how the environmental conditions may have an effect on work output and on its quality
- K21 the various types of tests that are carried out on the prepared surfaces to check their compliance with the specification
- K22 how to dispose of waste materials safely, including the environmental impact of the materials you are using and the minimisation of this impact
- K23 the extent of your own responsibility and whom you should report to if you have problems that you cannot resolve

Additional Information

Scope/range related to performance criteria

You must be able to:

1. Carry out **all** of the following during the preparation of the yacht or boat surfaces:
 - 1.1. adhere to procedures or systems in place for risk assessment, COSHH, personal protective equipment and other relevant safety regulations
 - 1.2. confirm that all necessary husbandry and containment arrangements are in place and are adequate
 - 1.3. confirm that appropriate emergency arrangements are in place for any confined space or other hazardous work
 - 1.4. ensure that safe working distance procedures are set up, where appropriate
 - 1.5. ensure that tools and equipment are correctly prepared for the operations being performed
 - 1.6. apply safe and appropriate working practices and procedures at all times
2. Carry out preparation activities on yacht or boat component surfaces, to include **both** of the following:
 - 2.1. unpainted surfaces
 - 2.2. painted surfaces
3. Carry out preparation activities on **two** of the following types of substrate:
 - 3.1. wood
 - 3.2. ferrous metals
 - 3.3. non-ferrous metals
 - 3.4. composite materials
 - 3.5. other materials (such as ceramic, compliant rubber/polymer, plastics)
4. Visually inspect surfaces and identify defects and surface preparation requirements for **four** of the following conditions:
 - 4.1. coating detachment
 - 4.2. surface contamination
 - 4.3. coating cure
 - 4.4. surface corrosion/pitting

- 4.5. paint coating defects (such as pinholing, chalking, cissing, cracking/crazing)
- 4.6. damaged or defective deck screed/covering
5. Prepare the surfaces using tools and techniques appropriate to the substrate, to include using **six** of the following:
 - 5.1. degreasing solvents
 - 5.2. chemical paint remover
 - 5.3. hand abrasives
 - 5.4. brushes or vacuum cleaner
 - 5.5. hand tools
 - 5.6. power wire brush
 - 5.7. power discing
 - 5.8. fresh water (alone or with detergent)
 - 5.9. low pressure water cleaning
 - 5.10. high pressure water cleaning
6. Carry out the preparation activities in **four** of the following situations:
 - 6.1. confined spaces (such as tanks, voids, double bottoms)
 - 6.2. internal spaces
 - 6.3. covered exteriors
 - 6.4. exposed exteriors
 - 6.5. weather decks
 - 6.6. outer bottoms
 - 6.7. hull bottoms
 - 6.8. at height
7. Carry out the preparation activities in **one** of the following yacht or boat working environments:
 - 7.1. ashore
 - 7.2. afloat
8. Use **three** of the following methods to check that the prepared surfaces meet the specified standard tests for moisture and temperature:
 - 8.1. visual examination
 - 8.2. salt testing kit
 - 8.3. surface profile gauge
 - 8.4. adhesion test
 - 8.5. press tape
 - 8.6. swabs
 - 8.7. surface profile comparators
 - 8.8. acid test
9. Carry out surface preparations on yacht or boat components, in accordance with **one** of the following:

- 9.1. BS or ISO standards and procedures
 - 9.2. customer (contractual) standards and requirements
 - 9.3. company standards and procedures
 - 9.4. paint/covering manufacturers recommendations
 - 9.5. recognised compliance agency/body's standards (such as Lloyds, Boat Safety Scheme, BMEA Code)
 - 9.6. other accepted international standards
10. Complete the relevant paperwork, to include **one** from the following and pass it to the appropriate people:
- 10.1. work authorisation documents
 - 10.2. acceptance documentation
 - 10.3. craft/vessel log
 - 10.4. job cards
 - 10.5. other specific recording method
11. Reinstate the work area on completion of the preparation activities, to include carrying out **all** of the following:
- 11.1. safely disposing of arisings and waste materials
 - 11.2. cleaning and returning all tools and excess materials
 - 11.3. removing protection and exclusion arrangements (if no longer required)
 - 11.4. completing all required records
