## Latin: Translating (Advanced Higher)

**SCQF:** level 7 (8 SCQF credit points)

### Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop and extend the advanced language skills needed for accurate translation of complex unseen Latin verse and prose texts into English. Learners also develop advanced knowledge and understanding of vocabulary, accidence and syntax.

Learners who complete this Unit will be able to:

- 1 Translate complex authentic unseen Latin verse and prose texts into English

This Unit is a mandatory Unit of the Advanced Higher Latin Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

### Evidence requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

For this Unit, learners will be required to provide evidence of at least two translations of complex authentic unseen Latin texts from Latin into English. The translations will be of at least one verse text and at least one prose text.

Evidence of Outcomes can be in written or oral form.

Learners will be allowed access to a word list under controlled assessment conditions.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
