

Unit outline

The general aim of this Unit is to develop learners' skills in evaluating political ideologies. Learners will apply knowledge and understanding of political concepts.

Learners who complete this Unit will be able to:

- 1 Use a wide-range of sources of information to evaluate different political ideologies and political concepts
- 2 Draw on theoretical and conceptual knowledge and understanding of the nature of power, authority and legitimacypolitical ideologies and political concepts

This Unit is a mandatory Unit of the Higher Politics Course and is also available as a free-standing Unit. The *Unit* specification should be read in conjunction with the *Unit* Support Notes, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit* Assessment Support.

The *Course Assessment Specification* for the Higher Politics Course gives further mandatory information on Course coverage for learners taking this Unit as part of the Higher Politics Course.

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Assessment evidence can be drawn from a number of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a number of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit, Units or Course as a whole by combining assessment holistically.

The theories and ideologies chosen do not need to belong to a defined time period.

The concepts of power, authority and legitimacy can be studied within any political context. The writings of Max Weber and Steven Lukes should be used for the study of

the conceptual models. For the ideologies, the ideas and writings of the following relevant theorists could be used:

- ◆ liberalism: Locke, Mill
- ◆ socialism Marx, Lenin
- ◆ conservatism Burke, Disraeli
- ◆ nationalism Mazzini, Herder
- ◆ fascism Mussolini, Hitler

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
