UNIT Roads Maintenance: An Introduction to Laying Kerbs and Channels (SCQF level 5)

SUMMARY

This Unit covers essential knowledge and practical experience relating to laying kerbs and channels in the Roads and Highways Maintenance environment. The Unit is suitable for candidates who have had little or no experience to date in the Roads Maintenance environment and who want to gain and apply knowledge and understanding of laying kerbs and channels in the workplace environment. Candidates will safely prepare for and lay kerbs and channels whilst complying with all relevant legislation.

OUTCOMES

- 1 Prepare for the construction of a kerbing and channels.
- 2 Prepare the site for laying kerbs and channels including a drop access kerb.
- 3 Lay kerbs and channels including a drop access kerb.

RECOMMENDED ENTRY

Entry to this Unit is at the discretion of the centre. This Unit is suitable for inexperienced or entry level candidates.

CREDIT VALUE

1 credit at SCQF level 6 (6 SCQF credit points at SCQF level 5*).

National Unit Specification: statement of standards

UNIT Roads Maintenance: An Introduction to Laying Kerbs and Channels (SCQF level 5)

Acceptable performance in this Unit will be the satisfactory achievement of the standards set out in this part of the Unit Specification. All sections of the statement of standards are mandatory and cannot be altered without reference to SQA.

OUTCOME 1

Prepare for the construction of a kerbing and channels.

Performance Criteria

- (a) Accurately interpret the given drawings, and contractor's specification for the work to be carried out.
- (b) Measure and calculate accurately the materials required for the work to be carried out for a minimum of 20 linear meters.
- (c) Select appropriate tools and equipment for the work to be carried out.
- (d) Select appropriate PPE equipment for a given task, in accordance with legislative requirements/and or organisational requirements.

OUTCOME 2

Prepare the site for laying kerbs and channels including a drop access kerb.

Performance Criteria

- (a) Check the site correctly for buried services and make ready to receive kerbs and channels.
- (b) Accurately set up pins and string lines to the required levels.
- (c) Place out selected kerbs and channel blocks to be laid.
- (d) Demonstrate the correct adherence to statutory requirements and/or safety notices and warning signs displayed in the workplace.

OUTCOME 3

Lay kerbs and channels including a drop access kerb.

Performance Criteria

- (a) Lay bedding accurately to required specifications.
- (b) Lay and align correctly, a minimum of 20 linear meters of either pre-cast concrete kerbs, whin kerbs or granite kerbs.
- (c) Lay accurately 20 linear meters of channelling.
- (d) Accurately lay drop access kerbs to required specifications.
- (e) Dispose of waste in accordance with legislation.

EVIDENCE REQUIREMENTS FOR THIS UNIT

Candidates must carry out a risk assessment before any practical activity.

Evidence is required to demonstrate that candidates have achieved all Outcomes and Performance Criteria. The specific Evidence Requirements for each Outcome are outlined below.

Written and/or oral evidence is required to demonstrate that the candidates have achieved Outcomes 1 and 2. The evidence will be produced under open-book supervised conditions within a time limit of 30 minutes.

Performance evidence supplemented with an assessor observation checklist is required to demonstrate that candidates have achieved the Performance Criteria in Outcomes 1, 2 and 3. The evidence will be produced under supervised conditions at appropriate points in the Unit once candidates have developed the necessary knowledge and skills.

These Evidence Requirements will be met by the completion of the Assessment Support Pack (ASP) that provides detailed assessment material for this Unit. Centres wishing to develop their own assessments should refer to the ASP to ensure a comparable standard.

National Unit Specification: support notes

This part of the Unit Specification is offered as guidance. The support notes are not mandatory.

While the exact time allocated to this Unit is at the discretion of the centre, the notional design length is 40 hours.

GUIDANCE ON THE CONTENT AND CONTEXT FOR THIS UNIT

This Unit is an optional Unit in the NPA in Roads Maintenance at SCQF level 5 but can also be taken as a free-standing Unit.

The content and context of this Unit is aimed at candidates who are interested in pursuing a career in highways maintenance. Candidates will be introduced to the laying of kerbs and channels and will gain practical experience of that activity.

The laying of kerbs and channels is integral and key to the Roads Maintenance Industry therefore throughout the Unit emphasis will be placed on the application of Safe Working Practices in line with current safety codes of practice and policies and regulations.

Centres may find opportunities to integrate this Unit with others in the Roads Maintenance NPA at SCQF level 5 eg some parts of this Unit could be combined with *Roads Maintenance: An Introduction to Searching for Underground Services* at SCQF level 5.

Site conditions should reflect as near as possible realistic working conditions.

GUIDANCE ON LEARNING AND TEACHING APPROACHES FOR THIS UNIT

The learning environment for this Unit will be a combination of classroom and workshop based learning where the candidate will be involved in group activities and discussions. The knowledge element of this Unit would be taught in a classroom environment and put into practice in conjunction with the practical Outcomes.

Candidates could work in pairs or groups on the practical activity, although they will need to meet all Evidence Requirements individually.

OPPORTUNITIES FOR CORE SKILL DEVELOPMENT

Opportunities may arise in this Unit for candidates to develop aspects of the following Core Skills:

- ◆ Communication at SCQF level 3 by reading and interpreting drawings and contractors' instructions
- ◆ Numeracy at SCQF level 3 by accurately setting up pins and string lines to required levels
- ◆ Working with Others at SCQF level 3 by working in groups and through lifting and handling in pairs

GUIDANCE ON APPROACHES TO ASSESSMENT FOR THIS UNIT

Centres may use the instruments of Assessment which they consider to be most appropriate but are encouraged to use the Assessment Support Pack (ASP) developed centrally by SQA. It is expected that candidates will be given as much practise as possible in the methods of safe working practice and risk assessment methods etc, prior to being set the assessment tasks.

For Outcomes 1 and 2 a suitable method for assessing candidate knowledge and understanding of laying kerbs and channels could be through a set of multiple choice questions.

For Outcomes 1, 2 and 3, to allow candidates to generate the Performance Evidence centres should set a series of practical assignments which accurately reflect the Unit content.

Opportunities for the use of e-assessment

E-assessment may be appropriate for some assessments in this Unit. By e-assessment we mean assessment which is supported by information and communications technology (ICT), such as e-testing or the use of e-portfolios or e-checklists. Centres which wish to use e-assessment must ensure that the national standard is applied to all candidate evidence and that conditions of assessment as specified in the Evidence Requirements are met, regardless of the mode of gathering evidence.
