



**Biology: Life on Earth (National 3)**

# **Unit outline**

The general aim of this Unit is to develop skills of scientific inquiry, investigation and knowledge and understanding of life on Earth. Learners will apply these skills when considering the applications of life on Earth on our lives, as well as the implications on society/the environment. This can be done by using a variety of approaches, including investigation and problem solving.

The Unit covers the key areas of sampling and identifying living things from different habitats to compare their biodiversity and suggest reasons for their distribution; different types of chemicals in agriculture; the alternatives and their impact on global food production. Learners will research issues, apply scientific skills and communicate information related to their findings, which will develop skills of scientific literacy.

Learners who complete this Unit will be able to:

- Apply skills of scientific inquiry and draw on knowledge and understanding of the key areas of this Unit to carry out an experiment/practical investigation
- 2 Draw on knowledge and understanding of the key areas of this Unit and apply scientific skills

This Unit is a mandatory Unit of the National 3 Biology Course and is also available as a free-standing Unit. The key areas covered in this Unit are: sampling and identifying living things from different habitats to compare their biodiversity and suggest reasons for their distribution; different types of chemicals in agriculture, the alternatives and their impact on global food production.
