2. investigate appropriate techniques and materials in stitched textiles and fashion;
3. produce work in stitched textiles and fashion;
4. formally present completed work in stitched textiles and fashion.

OUTCOME

1. RESEARCH A GIVEN BRIEF IN STITCHED TEXTILES AND FASHION

PERFORMANCE CRITERIA

- (a) Appropriate research sources are identified clearly.
- (b) Appropriate research materials are gathered.
- (c) The demands of the brief are complied with.

RANGE STATEMENT

The range for this outcome is fully expressed within the performance criteria.

EVIDENCE REQUIREMENTS

The candidate will be given a brief to follow and must show that he/she has followed it correctly. Evidence may be in the form of sketches, drawings or finished products showing how the brief has been followed.

OUTCOME

2. INVESTIGATE APPROPRIATE TECHNIQUES AND MATERIALS IN STITCHED TEXTILES AND FASHION

PERFORMANCE CRITERIA

- (a) Appropriate techniques are identified clearly.
- (b) Appropriate materials are identified clearly.
- (c) Appropriate tools and equipment are used correctly.

RANGE STATEMENT

The range for this outcome is fully expressed within the performance criteria.

EVIDENCE REQUIREMENTS

The candidate will be asked to investigate and determine which materials and stitched textile techniques are best used to complete a particular stitched textile product. Evidence may be in the form of sketches, drawings or written or oral descriptions of the materials and techniques to be used.

OUTCOME**3. PRODUCE WORK IN STITCHED TEXTILES AND FASHION****PERFORMANCE CRITERIA**

- (a) Appropriate methods and approaches for completing work are identified clearly.
- (b) Techniques and materials are used correctly.
- (c) The work conforms to the demands of the brief.

RANGE STATEMENT

The range for this outcome is fully expressed within the performance criteria.

EVIDENCE REQUIREMENTS

For this outcome, the candidate must produce at least one stitched textile product which conforms to the given brief referred to in outcome 1. Materials and techniques must be used correctly and in accordance with health and safety regulations.

OUTCOME**4. FORMALLY PRESENT COMPLETED WORK IN STITCHED TEXTILES AND FASHION****PERFORMANCE CRITERIA**

- (a) Appropriate methods of presentation are identified clearly.
- (b) Presentation methods and techniques are applied correctly.
- (c) Methods of presentation are appropriate to the demands of the brief.

RANGE STATEMENT

The range for this outcome is fully expressed within the performance criteria.

EVIDENCE REQUIREMENTS

For this outcome, the candidate will have to show how his/her product can best be displayed for presentation. Evidence will be formal presentation of the product in an appropriate way.

ASSESSMENT

In order to achieve this unit, candidates are required to present sufficient evidence that they have met all the performance criteria for each outcome within the range specified. Details of these requirements are given for each outcome. The assessment instruments used should follow the general guidance offered by the SQA assessment model and an integrative approach to assessment is encouraged. (See references at the end of support notes).

Accurate records should be made of the assessment instruments used showing how evidence is generated for each outcome and giving marking schemes and/or checklists, etc. Records of candidates' achievements should be kept. These records will be available for external verification.

UNIT TITLE: ART AND DESIGN: INTRODUCTION TO STITCHED TEXTILES

SUPPORT NOTES: This part of the unit specification is offered as guidance. None of the sections of the support notes is mandatory.

The modules "Introduction to Specialist Study" are part of a suite intended to form a coherent whole. At the moment they cover a small number of specialist fine art and design disciplines, but it is hoped that the format will allow for the introduction of other subjects within the same overall framework. As an introduction to specialist study, they should be seen as vehicles for creative experimentation within specific disciplines. They are not intended to mimic the realities of professional practice.

NOTIONAL DESIGN LENGTH: SQA allocates a notional design length to a unit on the basis of time estimated for achievement of the stated standards by a candidate whose starting point is as described in the access statement. The notional design length for this unit is 40 hours. The use of notional design length for programme design and timetabling is advisory only.

PURPOSE This module is part of a series in specialist studies: interior design, sculpture, exhibition design, photography, illustration, painting surface decoration, graphic and design. These modules are essentially diagnostic, and would ideally form part of a foundation programme of study.

The intention is to provide an opportunity for candidates to participate in an area of specialist study, of which they may have no previous experience, and to allow them to explore that area creatively, without undue emphasis being placed on the technical rigours associated with it. To this end, it is recommended that consideration is given to providing creative and imaginative briefs and projects freed, as far as is appropriate, from the constraints of professional practice. Likewise, any assessment of candidate achievement should bear in mind that individuals are being assessed not only in terms of ability, but also in terms of their enthusiasm in approaching a subject for which they may have little aptitude, but which has been offered to them in a spirit of 'try it and see'. On the other hand, the experience of the subject should be a realistic one, it being of little use to pretend that candidates for, say, Interior Design would not be expected to undertake the technical discipline of producing plans.

SQA publishes summaries of NC units for easy reference, publicity purposes, centre handbooks, etc. The summary statement for this unit is as follows:

This module offers candidates the opportunity to experience and experiment with an area of specialist study which may be new to them.

Candidates will be encouraged to investigate techniques and materials creatively and produce work in response to a given brief.

CONTENT/CONTEXT The following information gives further clarification regarding the context in which the outcomes and performance criteria are to be achieved.

Outcome 1

The term 'brief' here covers both the instructions set out in finding the solution to a design problem, and the sort of project which might be set for candidates of a fine art discipline. In any case, it should be imaginative, and allow for individual creativity, and the constraints involved should not necessarily be those of real professional practice.

The intention here is that individuals should be introduced to stitched textiles and fashion design through machine techniques and contemporary mixed media techniques such as papermaking, felting, dyeing, and printing of fabric taken into fashion.

Outcome 2

The investigation of techniques and materials should be approached with the idea that candidates should experience in broad terms the skills and use of media associated with a particular discipline. While it would serve no useful purpose in the context of this module to lay down specific techniques and materials within each area of study which should of necessity be experienced, neither would it be appropriate for candidates to gain the impression that specialist disciplines are alike. Where particular technical demands, and skill in the use of specific materials form an integral part of a specialist area, it would be unwise to avoid this fact when introducing candidates to this area, and some thought should be given in this respect.

For stitched textiles and fashion, specialist sewing or pattern cutting techniques may well be avoided completely, and it may be advisable to avoid also the use of fabric, and to substitute mixed media techniques to simulate the experience of working with materials.

Outcome 3

The term 'work' here covers a single, and not overly ambitious, project, which might reasonably be undertaken by a candidate with no previous experience in that area. While it is essential that candidates should produce work which reflects their experience of the subject area, the finished item or items may take secondary importance, in terms of scale and ambition, to the creative and investigative process which has gone before.

Outcome 4

The presentation of completed work should be seen as completing the introduction to specialist study, and may involve mounting work on boards, in a portfolio, or on display.
