



Practical Craft Skills: Making a Craftwork Item (National 2)

SCQF: level 2 (6 SCQF credit points)

Unit code: H25F 72

Unit outline

The general aim of this Unit is to provide an opportunity for the learner to manufacture a craft item to a given standard and for a given purpose, including the selection of appropriate tools, equipment and materials, and using media and technology as appropriate within the production process. If appropriate, basic finishes may be applied to the finished item.

The item can be entirely of one material or, alternatively, can be made of a combination of materials. Any suitable material can be used (which can include wood, metal, plastics, glass, textiles or clay). The learner will develop an understanding of the need for safe working practices in a working environment, and of the need for the efficient use of tools and materials in a practical crafts context.

Learners who complete this Unit will be able to:

- 1 Prepare to make a craftwork item to a given standard and for a given purpose
- 2 Make a craftwork item to a given standard and for a given purpose
- 3 Demonstrate an understanding of the need to use materials efficiently

This Unit is a mandatory Unit of the National 2 Practical Craft Skills Course and is also available as a free-standing Unit. Standards

Outcomes and assessment standards

Outcome 1

The learner will:

- 1 Prepare to make a craftwork item to a given standard and for a given purpose by:
- 1.1 Choosing tools, equipment, media or technology appropriate to the craftwork item
- 1.2 Choosing materials appropriate to the craftwork item
- 1.3 Showing understanding of the plan and/or design for the craftwork item

Outcome 2

The learner will:

- 2 Make a craftwork item to a given standard and for a given purpose by:
- 2.1 Following given instructions and procedures for the production process
- 2.2 Using tools and/or equipment and materials correctly
- 2.3 Using media and/or technology correctly
- 2.4 Following health and safety requirements when using equipment
- 2.5 Following rules for personal safety when using equipment
- 2.6 Producing a finished craftwork item

Outcome 3

The learner will:

- 3 Demonstrate an understanding of the need to use materials efficiently by:
- 3.1 Tidying up personal work area during a period of craftwork activity as well as on completion
- 3.2 Safely storing craftwork item during a period of craftwork activity as well as on completion
- 3.3 Returning excess and/or unused materials to storage during a period of craftwork activity as well as on completion
- 3.4 Explaining reasons for storing excess and/or unused materials

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

In this Unit, Evidence Requirements are as follows.

Evidence may be presented for individual Outcomes or it may be gathered for the Unit as a whole through integrating assessment in one single activity. If the latter approach is used, it must be clear how the evidence covers each Outcome.

For Outcomes 1 and 2, evidence is required of the learner's ability to safely and correctly select and use tools, equipment, media, technology and materials appropriate to the craftwork item. The selection of at least one item of media or technology is required. Evidence is required that the learner understands the plan or design of the craftwork item and the activities required to create the finished item. Evidence is required of the learner's ability to carry out and complete the activities necessary to produce the finished item.

One finished craftwork item is required.

Evidence is required of the learner's ability to follow instructions to ensure safe working practices in their personal learning environment and in the working environment.

For Outcome 3, evidence is required of the learner's ability to decide what to do with and then deal with excess and/or unused materials during and on completion of the craftwork activity. Evidence is required of the learner's ability to keep their personal working area tidy during and on completion of the craftwork activity, including safe storage of craftwork items.

It is expected that learners will receive support to achieve the Outcomes of this Unit.

Evidence may take a variety of formats, such as written, oral, or pictorial, and may be gathered using the learner's usual means of communication.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the Unit where there are appropriate opportunities.
