



Cell Biology (National 3) Unit

Unit outline

The general aim of this Unit is to develop skills of scientific inquiry, investigation and knowledge and understanding of cell biology. Learners will apply these skills when considering the applications of cell biology on our lives, as well as the implications on society/the environment. This can be done by using a variety of approaches, including investigation and problem solving.

The Unit covers the key areas of structure and variety of cells and their functions; function of DNA; risks and benefits of DNA profiling; photosynthesis; different types of microorganisms and how growth of microorganisms can be controlled. Learners will research issues, apply scientific skills and communicate information related to their findings, which will develop skills of scientific literacy.

Learners who complete this Unit will be able to:

- 1 Apply skills of scientific inquiry and draw on knowledge and understanding of the key areas of this Unit to carry out an experiment/practical investigation
- 2 Draw on knowledge and understanding of the key areas of this Unit and apply scientific skills

This Unit is a mandatory Unit of the National 3 Biology Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Evidence Requirements for the Unit

The key areas covered in this Unit are: structure and variety of cells and their functions; function of DNA; risks and benefits of DNA profiling; photosynthesis; different types of microorganisms and how growth of microorganisms can be controlled.

Evidence can be drawn from a variety of sources and presented in a variety of formats. The table below describes the evidence for the Assessment Standards which require exemplification. Evidence may be presented for individual Outcomes or gathered for the Unit as a whole, through combining assessment holistically in a single activity.
