



Nature's Chemistry (National 3)

SCQF: level 3 (6 SCQF credit points)

Unit outline

The general aim of this Unit is to develop skills of scientific inquiry, investigation, and knowledge and understanding of nature's chemistry. Candidates will apply these skills when considering the applications of nature's chemistry on our lives, as well as the implications on the environment/society'. This can be done by using a variety of approaches, including investigation and problem solving.

The Unit covers the key areas of fuels and energy everyday consumer products, and plants to products.

Learners will research issues, apply scientific skills and communicate information related to their findings, which will develop skills of scientific literacy.

Learners who complete this Unit will be able to:

- 1 Apply skills of scientific inquiry and draw on knowledge and understanding of the key areas of this Unit to carry out an experiment
- 2 Draw on knowledge and understanding of the key areas of this Unit and apply scientific skills

This Unit is a mandatory Unit of the National 3 Chemistry Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

Recommended entry

Entry to this Unit is at the discretion of the centre. However, learners would normally be expected to have attained the skills, knowledge and understanding required by the following or equivalent qualifications and/or experience:

- ◆ National 2 Science in the Environment Course or relevant component Units

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their candidates, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

The key areas covered in this Unit are:

- ◆ **fuels and energy**
- ◆ **everyday consumer products**
- ◆ **plants to products**

Evidence can be drawn from a variety of sources and presented in a variety of formats. The table below describes the evidence for the Assessment Standards which require exemplification. Evidence may be presented for individual Outcomes or gathered for the Unit as a whole, through combining assessment holistically in a single activity.
