Understanding 20th and 21st Century Music (National 3)

Unit outline

The general aim of this Unit is to enable learners to develop knowledge and understanding of some important 20th and 21st century musical styles and genres, and developments in music technology, through investigation and listening activities.

Learners who complete this Unit will be able to:

- 1 Describe, in simple terms, technological developments and 20th and 21st century music
- 2 Use listening skills in the context of 20th and 21st century music

This Unit is a mandatory Unit of the National 3 Music Technology Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

For this Unit, learners must provide evidence of their understanding of aspects of 20th and 21st century music, and related technological developments. Evidence for Outcomes 1 and 2 could be generated through a single activity, but is more likely to be generated over a series of activities.

Evidence for Outcome 1 should be in an appropriate format that can be presented to others, which may be visual, written, oral, electronic or some other format.

Evidence for Assessment Standard 1.1 should refer to at least two different genres. Appropriate genres could include jazz, blues, rock and disco. Evidence for Assessment Standard 1.2 should refer to at least two technologies.

Relevant music concepts for Outcome 2 should include basic terms relating to melody and harmony, rhythm and tempo, texture, structure and form, and timbre and dynamics.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the Unit where there are appropriate opportunities.
