



ESOL for Everyday Life (National 4)

Unit outline

The general aim of this unit is to develop the language skills needed for everyday life in familiar personal, social and transactional contexts for learners whose first language is not English. Learners develop the skills of reading, writing, listening, and speaking, using straightforward English language.

Learners who complete this unit will be able to:

- 1 Understand straightforward language written in English
- 2 Produce written English using straightforward language
- 3 Understand straightforward language spoken in English
- 4 Communicate orally in English using straightforward language

This unit is a mandatory unit of the National 4 ESOL course and is also available as a freestanding unit. The unit specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this unit is given in unit assessment support.

The Added Value Unit Specification for the National 4 ESOL course gives further mandatory information on course coverage for learners taking this unit as part of the National 4 ESOL course.

Evidence requirements for the unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

For this unit, learners will be required to provide evidence of their reading, writing, listening, and speaking skills by:

- understanding at least one text written in straightforward English language
- producing at least one written text using straightforward English language
- understanding at least one text spoken in straightforward English language
- communicating orally in at least one interaction using straightforward English language

Evidence should be gathered in combination with other outcomes where possible, either from this unit or in combination with the outcomes from the unit *ESOL* in *Context*. Evidence may also be gathered for individual outcomes where appropriate.

Contexts will be drawn from at least one familiar personal, social or transactional context.

Exemplification of assessment is provided in unit assessment support. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this unit. The skills that learners will be expected to improve on and develop through the unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the unit where there are appropriate opportunities.
