## Historical Study: European and World (National 4)

**SCQF:** level 4 (6 SCQF credit points)

**Unit code:** H20D 74

### Unit outline

The general aim of this Unit is to develop the learner's skills in commenting on the factors contributing to historical developments. Learners will apply knowledge and understanding of European and world historical events and themes.

Learners who complete this Unit will be able to:

- 1 Comment on the factors contributing to historical developments
- 2 Draw on and apply knowledge and understanding of European and world historical events and themes

This Unit is a mandatory Unit of the National 4 History Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provides advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *Unit Assessment Support*.

The *Added Value Unit Specification* for the National 4 History Course gives further mandatory information on Course coverage for learners taking this Unit as part of the National 4 History Course.

## Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Learners may describe and comment on specific historical events but also historical themes such as heritage, change and continuity, and cause and effect. The sources used may be written, numerical, graphical, audio visual, pictorial or oral. Artefacts may also be used.

Assessment evidence can be drawn from a variety of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions, and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit, Units or Course as a whole by combining assessment holistically.

Exemplification of assessment is provided in the *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

## **Assessment standard thresholds**

If a candidate successfully meets the requirements of the specified number of Assessment Standards they will be judged to have passed the Unit overall and no further re-assessment will be required.

The specific requirements for this Unit is as follows:

- ◆ 3 out of 4 Assessment Standards must be achieved.

It should be noted that there will still be the requirement for candidates to be given the opportunity to meet all Assessment Standards. The above threshold has been put in place to reduce the volume of re-assessment where that is required.

It is expected that learners will develop broad, generic skills through this Unit.
