Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop the skills needed to plan and create straightforward media content and to comment on production processes. Learners develop knowledge of the key aspects of media literacy central to creating straightforward media content.

Learners who complete this Unit will be able to:

1 Create straightforward media content

This Unit is a mandatory Unit of the National 4 Media Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Outcomes and assessment standards

Outcome 1

The learner will:

- 1 Create straightforward media content by:
- 1.2 Planning and developing ideas in response to a negotiated brief
- 1.2 Using production skills appropriate to the media content and context
- 1.3 Commenting on the production process
- 1.4 Applying knowledge of relevant key aspects of media literacy

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence should be gathered in combination with other Outcomes where possible, in combination with the Outcome from the Unit *Analysing Media Content* (National 4). Evidence may also be gathered for individual Outcomes where appropriate.

For this Unit, learners will be required to provide evidence of each of the following in response to a negotiated brief:

- straightforward planning and research skills
- straightforward production skills (can include pre-production, production and postproduction)
- straightforward evaluation skills
- knowledge of the key aspects of media literacy central to creating straightforward media content

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the Unit where there are appropriate opportunities.
