UNIT Stonemasonry: Build Radius Walling (SCQF level 6)

SUMMARY

This Unit is suitable for candidates working towards a Modern Apprenticeship in Stonemasonry and will develop the candidates craft skills in building radius walling and pointing. This Unit is designed to provide candidates with competence in the use of tools and equipment to set out and build a feature radius wall and the ability to apply these skills in the workplace. It is also designed to enable candidates to develop their skills and understand and use stonemasonry terminology, techniques and practices, produce working drawings and set out and build a radius wall using a trammel.

OUTCOMES

- 1 Demonstrate knowledge and understanding of terminology, components and construction practices used in setting out and forming radial walls.
- 2 Set out and build circular rubble walling on plan.
- 3 Mix mortar and point circular walling.

RECOMMENDED ENTRY

While entry to this Unit is at the discretion of the centre, candidates undertaking the Professional Development Award in stonemasonry at SCQF level 6 must meet the requirements of the Modern Apprentices which include being employed in the relevant craft industry.

Acceptable performance in this Unit will be the satisfactory achievement of the standards set out in this part of the Unit Specification. All sections of the statement of standards are mandatory and cannot be altered without reference to SQA.

OUTCOME 1

Demonstrate knowledge and understanding of terminology, components and construction practices used in setting out and forming radial walls.

Performance Criteria

- (a) Identify and select terminology related to circular walling.
- (b) Identify and select components used in circular walling.
- (c) Identify and select setting out techniques correctly using a trammel.

OUTCOME 2

Set out and build circular rubble walling on plan.

Performance Criteria

- (a) Set out wall in accordance with the given specification.
- (b) Build circular rubble wall in accordance with the given specification.
- (c) Comply with current Health and Safety requirements during all work methods and activities.

OUTCOME 3

Mix mortar and point circular walling.

Performance Criteria

- (a) Mix mortar for given task correctly.
- (b) Flush point circular walling.
- (c) Comply with current Health and Safety requirements during all work methods and activities.

EVIDENCE REQUIREMENTS FOR THIS UNIT

These Evidence Requirements will be met by the completion of the Stonemasonry Training and Assessment Programme (TAP).

Evidence is required to demonstrate that the candidate has achieved this Unit to the standard specified in all Outcomes and Performance Criteria.

Written and/or oral recorded evidence is required to demonstrate that the candidate has achieved Outcomes 1 to the standard specified in the Performance Criteria. Candidates will be required to demonstrate their knowledge of terminology, techniques and practices by defining terms, describing setting out techniques and identifying required construction practices. Assessment will take the form of a question paper which will be carried out under controlled, supervised conditions. Evidence will be gained in the form of both closed and open-book depending on the Instrument of Assessment.

Product and performance evidence is required to demonstrate that the candidate has achieved Outcomes 2 and 3 to the standards specified in the Performance Criteria. Candidates will be required to build circular walling using a trammel and point the completed job. Assessment of these Outcomes will be evidenced through observation of work processes and assessment of completed work pieces. Candidates must meet the given standards and tolerances during the practical assessments. An assessor observation checklist must be used to record this evidence. Assessment should be conducted under controlled, supervised conditions. Assessment of these Outcomes will be carried out in a workshop under controlled supervised conditions.

National Unit Specification: support notes

UNIT Stonemasonry: Build Radius Walling (SCQF level 6)

This part of the Unit Specification is offered as guidance. The support notes are not mandatory.

While the exact time allocated to this Unit is at the discretion of the centre, the notional design length is 40 hours.

GUIDANCE ON THE CONTENT AND CONTEXT FOR THIS UNIT

This Unit has been developed as a mandatory Unit in the Professional Development Award in Stonemasonry at SCQF level 6.

The successful completion of this Unit will provide candidates with the required underpinning knowledge and skills relating to setting out techniques and construction practices associated with building radial walling using a trammel and pointing.

This Unit should be offered to candidates from the construction and related services industries. The skills and knowledge and understanding are transferable within different working environments but the Unit is primarily aimed at candidates whose normal place of work would be a site, workshop, or similar environment.

The Unit deals with building of radial walling using a trammel and pointing. It should be delivered as part of a structured programme of training and orientated to the context of the candidate's work and area of responsibility.

Health and safety and sustainability are integral and key to the construction industry therefore throughout the Unit emphasis will be placed where appropriate on the application of health and safety and sustainability. Safety working practices should be looked at in accordance with current safety codes of practice and regulations. Sustainability should include reference to criteria affecting sustainability, impact of not implementing sustainability on the environment and the legislation promoting sustainability.

GUIDANCE ON LEARNING AND TEACHING APPROACHES FOR THIS UNIT

The candidate should be given the opportunity to further develop the skills of bed spreading and jointing used in the stonemasonry craft. The use of a pocket level should be encouraged for levelling the stonework. The terms used for radial walling and pointing should be integrated to the practical assessments as it is undertaken, and the basic principles of such explained as the workpiece is being built.

This teaching approach should ensure the candidate is acquiring the underpinning knowledge required for the Unit. Teachers/Lecturers should demonstrate practical elements step-by-step until they feel that the candidate is competent to attempt tasks under assessment conditions. Effective questioning should be encouraged throughout, focusing on skills construction practices and underpinning knowledge related to radial walling structures.

It is recommended that this Unit be delivered in order of Outcomes as the order stated in the Statement of Standards.

Opportunities should be taken throughout delivery of this Unit to meet the requirements of the generic Units of the Training and Assessment Programme including:

- ◆ Confirm the Occupational Method of Work

OPPORTUNITIES FOR CORE SKILL DEVELOPMENT

Components of the Core Skill of *Problem Solving* at SCQF level 4 such as Planning and Organising and Critical Thinking will be developed as candidates undertake this Unit. Candidates will need to take account of a range of factors in order to work efficiently and safely, such as the choice of tools, appropriate materials, safety issues, safety equipment and sustainability. Individual discussions with assessors will enhance the evaluation of efficient working practices.

There are opportunities for candidates to develop the Core Skill of *Working with Others* at SCQF level 4, particularly in Outcomes 2 and 3 as this practical assessment may be carried out working in pairs, as part of teaching and learning. Candidates can agree responsibilities and provide support and information to each other during the assessments. After assessment, they should be encouraged to consider how effectively they supported each other.

Opportunities also arise for candidates to develop the Core Skill of *Information and Communication Technology* at SCQF level 3 by researching Health and Safety legislation affecting their area of work.

Numeracy at SCQF level 4 could be developed through the interpretation of information from three dimensional working drawings and the practical use of calculation and measuring scales required for teaching and learning assessments for Outcomes 2 and 3.

There will be opportunities for candidates to develop the Core Skills of *Communication* at SCQF level 4. Candidates will have the opportunity to develop written and/or oral communication skills for the knowledge part of the assessment for Outcome 1. As candidates complete practical tasks, they should be expected to communicate with others using the correct terminology, tone and style suited to the workplace.

GUIDANCE ON APPROACHES TO ASSESSMENT FOR THIS UNIT

Detailed assessment materials for this Unit will be found in section 5 of the Stonemasonry TAPS. Centres may use the instruments of assessment which they consider to be most appropriate but are advised to use the Stonemasonry TAP which has been developed centrally by SQA. Any other instruments of assessment used must be comparable to the TAP and have been through prior verification.

The candidate's knowledge and understanding of terminology, techniques and construction practices of stonemasonry will be assessed through a question paper.

Candidates should be given as much practise as possible in building radial walling and pointing techniques, prior to being set the assessment assessments Evidence will be gathered for Outcomes 2 observation that the candidates have met the given standards and tolerances during the practical assessment. An assessor observation checklist can be used to record this evidence.

Opportunities for the use of e-assessment

E-assessment may be appropriate for some assessments in this Unit. By e-assessment we mean assessment which is supported by Information and Communication Technology (ICT), such as e-testing or the use of e-portfolios or e-checklists. Centres which wish to use e-assessment must ensure that the national standard is applied to all candidate evidence and that conditions of assessment as specified in the Evidence Requirements are met, regardless of the mode of gathering evidence.
