# Unit outline

The general aim of this Unit is to develop the ability to express views about contemporary moral questions and responses. Learners will develop basic knowledge and understanding of contemporary moral questions and religious and non-religious responses.

Learners who complete this Unit will be able to:

- 1 demonstrate an awareness of contemporary moral issues
- 2 express a supported view on a contemporary moral issue

This Unit is a mandatory Unit of the National 3 Religious, Moral and Philosophical Studies Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *Unit Assessment Support*.

The learner will:

#### 2 Express a supported view on a contemporary moral issue by:

- 2.1 Presenting a simple viewpoint on a contemporary moral issue
- 2.2 Stating a reason in support of a personal viewpoint in simple terms

## **Evidence requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Assessment evidence can be drawn from a variety of activities and presented in a variety of formats including, for example, presentations, posters, brief written responses to questions, or participation in group tasks. All of the evidence does not need to come from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit, Units or Course as a whole by combining assessment holistically.

Religious responses studied must be from one of the world's six major religions (Buddhism, Christianity, Hinduism, Islam, Judaism or Sikhism).

All the Outcomes may be addressed through studying a single moral question.

Exemplification of assessment is provided in the *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
