## Fashion and Textile Technology: Textile Technologies (National 4)

**SCQF:** level 4 (6 SCQF credit points)

**Unit code:** H24V 74

### Unit outline

This Unit provides learners with the opportunity to develop straightforward knowledge and skills related to textile technologies. This includes knowledge of the characteristics and properties of a range of fabrics and their uses. Learners will have the opportunity to make straightforward fashion/textile items, to an appropriate standard of quality, using a pattern and a range of textile construction techniques. The Unit also provides learners with the opportunity to select, set up and use equipment and tools safely and correctly.

Learners who complete this Unit will be able to:

- 1 Prepare to make straightforward fashion/textile items using a pattern
- 2 Make straightforward fashion/textile items using a pattern

This Unit is a mandatory Unit of the National 4 Fashion and Textile Technology Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

The *Added Value Unit Specification* for the National 4 Fashion and Textile Technology Course gives further mandatory information on Course coverage for learners taking this Unit as part of the National 4 Fashion and Textile Technology Course.

In terms of prior learning and experience, relevant experiences and outcomes may also provide an appropriate basis for doing this Unit.

- 2 Make straightforward fashion/textile items using a pattern by:**
  - 2.1 Selecting appropriate equipment and tools to make the chosen item
  - 2.2 Setting up equipment correctly and according to safety guidelines
  - 2.3 Using equipment and tools correctly and according to safety guidelines
  - 2.4 Making a straightforward fashion/textile item using the pattern and appropriate textile construction techniques, to an appropriate standard of quality

## Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

For this Unit, evidence may be presented for individual Outcomes or it may be gathered for the Unit as a whole through integrating assessment in a single assessment event. If the latter approach is used, it must be clear how the evidence covers each Outcome.

The textile(s) selected for the chosen item must be suitable for the purpose of the item and suitable in weight and texture. Learners must work in accordance with health and safety guidelines. For Outcome 2, learners will be required to make a complete fashion/textile item using a pattern.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

It is expected that learners will develop broad, generic skills through this Course.
