Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop the skills needed to plan and create media content, and to evaluate production processes. Learners develop detailed knowledge and understanding of the key aspects of media literacy central to creating media content.

Outcome 1

The learner will:

1 Create media content by:

- 1.1 Planning and developing detailed ideas in response to a negotiated brief
- 1.2 Applying sustained production skills appropriate to the media content and context
- 1.3 Evaluating the production process in detail
- 1.4 Applying detailed knowledge and understanding of relevant key aspects of media literacy

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence should be gathered in combination with other Outcomes where possible, in combination with the Outcome from the Unit *Analysing Media Content* (Higher). Evidence may also be gathered for individual Outcomes where appropriate.

For this Unit, learners will be required to provide evidence of the following:

- ◆ detailed planning and research skills in response to a negotiated brief
- ◆ sustained production skills (can include pre-production, production or post-production)
- ◆ a range of evaluation skills
- ◆ detailed knowledge of key aspects central to creating media content

Exemplification of assessment is provided in Unit Assessment Support. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
