# **Evidence Requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the candidate has met the Outcomes and Assessment Standards.

Candidates are required to produce a critical evaluation about a current complex geographical issue. The critical evaluation will be based on sources containing differing viewpoints about a particular geographical issue. The viewpoints do not need to be radically different from each other or even necessarily opposed, but they should provide sufficient variation for candidates to write a critical evaluation.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Course/Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
