## **Outcomes and Assessment Standards**

### Outcome 1

The learner will:

### 1 Critically evaluate arguments from the philosophy of religion by:

- 1.1 Providing an in-depth account of one claim about the existence of God
- 1.2 Analysing the basis of the claim about the existence of God
- 1.3 Evaluating, in depth, one criticism of the claim about the existence of God and a counter argument against the criticism
- 1.4 Developing a well-reasoned conclusion on the claim about the existence of God

## **Evidence Requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Assessment evidence can be drawn from a variety of activities and presented in a variety of formats, including, for example, presentations, essays, written responses to questions and participation in group tasks. The evidence does not need to come e from a single activity, but can be assembled from a variety of tasks and assessments carried out during the Course.

Evidence may be presented for individual Assessment Standards or gathered for the Unit as a whole.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Course/Unit Support Notes*.
